The Equal Protection Task Force, African-American Residents, initially met on Tuesday, September 25, 2018, 6:30-7:30 p.m., at City Hall. Out of the nine persons who were asked, and have accepted, to serve on the Task Force, seven of them attended this first meeting. (The valid absences of the two remaining members are noted.) Ward 3 Alderwoman Pindell Charles attended.

The following nine persons have been selected to serve on the Task Force:

**Transportation – Ms. Barbara L. Harris**

Ms. Harris is a multi-generational and life-long resident of Annapolis, a product of our Annapolis public schools' system, and a long-time Annapolis homeowner. She has been a very frequent and regular Annapolis City bus rider for over 4 decades. As such, she has become and remains very cognizant and "in tune" to the daily operations of our transit system from a ridership point of view. She has used our transit system as a means to travel to her employment (Nationwide Insurance; and Anne Arundel Medical Center from where she retired), for shopping, as well as for pleasure. Ms. Harris relies on our City transit system to provide her with safe, reliable, accessible, and affordable transportation.

**Education – Ms. Rita Dorsey Washington**

Ms. Dorsey Washington has multi-generational roots in Annapolis and is a product of our Annapolis public schools' system. Currently, she serves as an Anne Arundel County Public Schools Community Ambassador based at Annapolis High School—serving the Woodside Gardens community, and the Newtowne 20 community where she grew up. Recently, she was selected to serve as the Resident Services Coordinator for the Woodside Gardens community. She has and continues to tirelessly support and/or initiate various programs in these two communities. Ms. Dorsey Washington is also a published author of two books—the latest one is entitled: "Can Any Good Come from Newtowne 20?"

**Communication – Mr. Doug Smith**

Mr. Smith is a decades long resident of Annapolis. He frequently testifies before the City Council. He has held several leadership positions in Annapolis, including serving as Chairperson and/or Member for Mayoral

Transition Teams. His decades-long advocacy, especially in the city of Annapolis, is very well known and very well respected. Mr. Smith and his wife Karen are now “part of a community effort to deal with some major problems in our area that have existed for years”. This non-partisan group, ACT (Anne Arundel Connecting Together), is comprised of over 1,000 persons, which include over 20 local churches and community organizations, and it is open to anyone and everyone—Presbyterians, Methodists, Baptists, Muslims, White, Black, and Latino. The issues that ACT has identified are those, which are definitely aligned with this Task Force. Mr. Smith’s ability to communicate and work simultaneously with this Task Force and ACT is critical and very much appreciated.

#### **Economics and Finances – Mr. Randall Robinson**

Mr. Robinson is the Assistant Vice President and Branch Manager of Wells Fargo Bank for South Central Maryland. His office is located at the Annapolis Mall branch. The staff at his Annapolis Mall branch office reflects the demographics of our Annapolis area. As a very hands-on Branch Manager, he interacts directly with the African-American population of varying socio-economic statuses. In addition, Mr. Robinson is the Membership Chair of the newly formed (as of April 2018) “Annapolis/Anne Arundel County Financial Education Coalition”, which is a part of the Statewide organization “CASH Campaign of Maryland—Creating Assets, Savings, and Hope”.

#### **Social and Political Concerns - Bishop Craig Coates**

Bishop Coates has been a multi-generational and life-long resident of Annapolis, as well as being a product of our Annapolis public schools’ system. He has been a very successful entrepreneur for over 3 decades, as well as serving as the Pastor of Fresh Start Church. He is also the Chaplain for the Annapolis City Police Department. Additionally, he has been the Convener of the “One Annapolis: Eastport Working Together” meetings since December 2017—meetings held twice per month, which began in October 2017, and where the five core issues that the residents have identified are: Education, Jobs/Workforce, Public Safety, Community Services, and Social Services. Bishop Coates’ work in and around the Annapolis and County community is legendary.

#### **Health Care – Ms. Marsella Haskins-Hare**

Ms. Haskins-Hare is the Deputy Executive Director of Hands of Hope, Inc., based in Annapolis. In particular, she supervises the Strengthening Families Program in Annapolis as well as in other parts of our County, including at Ordnance Road. For decades, Hands of Hope has provided this Program to hundreds of area families through contracts with the Anne Arundel County Health Department. Moreover, through Hands of Hope and other organizations, she has and continues to provide a multitude of contractual services through the County Health Department, and through the State Health Department as well. Ms. Haskins-Hare tirelessly and regularly leads, assists, participates, and/or attends many health-related programs, fairs, conferences, conventions, workshops, coalitions, etc., throughout Annapolis, Anne Arundel County, regionally, and State-wide.

#### **Housing – Ms. Bridget McLaughlin**

Ms. McLaughlin currently serves as the Resident Services Director for the Housing Authority of the City of Annapolis (HACA). For several years before arriving in Annapolis, she served in similar roles in the Washington, DC public housing community. As the Resident Services Director for HACA for less than 6 months, she has certainly “jumped in, feet first”. Ms. McLaughlin’s tireless, unyielding, and unending efforts on behalf of our residents, and especially our children over this past summer 2018, have truly gained her the respect of our community.

#### City Services and Outreach – Mr. Adetola Ajayi, Chair

Mr. Ajayi, having multi-generational roots in Annapolis, is also a product of our Annapolis area/ Broadneck public schools’ system. He is a graduate of Morgan State University with a degree in Economics. As such, he has a laser focus on statistics, data, entrepreneurship, and history, and how they intersect in today’s society and within our African-American community in particular. Since April 2018, he has served as the City’s African American Community Services Specialist in the Office of the Mayor. As such, he has initiated and/or taken on many of the Mayor’s “One Annapolis” outreach responsibilities and projects that are being carried out very successfully since the beginning of his tenure with the City. In particular, Mr. Ajayi, after digging into the City’s statistical data, has aggressively initiated a Citywide program that begins to address the current substance abuse crisis that is currently plaguing Annapolis’ African-American community especially in 2018; and thereafter, he will be exploring the companion issues of mental health, combined with historical facts and data, insights, and perspectives.

#### Workforce – Ms. Sara Ironman

Ms. Ironman currently serves as the Community Workforce Specialist for the Anne Arundel Workforce Development Corporation (AAWDC). She has been with AAWDC for approximately 3 years—serving at their Maryland Department of Social Services Office in Annapolis, as well as serving as a Placement and Retention Counselor, a Career Coach, and a Career Navigation Specialist. Prior to her career with AAWDC, she served as an Income Maintenance Caseworker in the Career Development Unit of the Philadelphia County Assistance Office for the Commonwealth of Pennsylvania (Pennsylvania’s equivalent of the Department of Social Services). AAWDC recently opened their new, and unprecedented, satellite office in Annapolis at the Stanton Community Center, a City facility, in March 2018. Ms. Ironman’s professional experience, combined with her current position at the Stanton Community Center, has enabled her to successfully provide individual assistance as well as workforce related educational workshops and opportunities to approximately 150 clients on multiple occasions since March, with a mobile component, that is a part of AAWDC’s toolbox, thereby, being able to assist all of Annapolis’ communities. Consequently, these individuals that she has helped—not only has she helped them on an individual basis, but she has helped their families in Annapolis as well—an impactful number that goes way beyond each individual that she has assisted and served.

The Task Force made the decision to form a Subcommittee, with several focuses. So far, the following three persons will be serving on the Task

**Force's Subcommittee:**

**Mr. Raymond Medley**  
**Public Health**

Mr. Medley is a multi-generational and life-long resident of Annapolis, as well as being a product of our Annapolis public schools' system. Currently, he serves as the extremely active and knowledgeable Anne Arundel County Department of Health, Community Engagement Outreach, Health Educator—leading and assisting with many different programs and initiatives. For many years, Mr. Medley has worked with the Hands of Hope, Inc.'s Strengthening Families Program—working very closely with Ms. Marsella Haskins-Hare.

**Mr. Archie J. Trader, III**  
**Recreation, Exercise, Leisure, and Nutrition; and**  
**Faith-Based Initiatives**

Mr. Trader is a multi-generational and life-long resident of Annapolis, as well as being a product of our Annapolis public schools' system. He is a graduate of Morgan State University with a degree in Recreation. He retired from the Maryland State Correctional System. After which, he joined the City government—first serving as the Recreational manager, and then the Facilities Supervisor both at the Stanton Community Center; and most recently, as the City's Director of the Department of Recreation and Parks. In the spring of 2016, Mr. Trader, along with retired Anne Arundel County Public Schools' Pupil Personnel Worker and Minister Sharon Mackell, then HACA Executive Director Melvin Colbert, and City Alderwoman Rhonda Pindell Charles, formally organized the "Street Corner Ministries Coalition". The purpose of the Coalition is to solicit area houses of worship to "adopt" our 15 public and subsidized housing communities—a one-to-one "adoption" whereby the houses of worship would provide whatever resources and services that the communities are in need of; and then expanding the mission to include the "adoption" by businesses, health entities, etc. In 2018 and 2019, the Coalition is continuing its mission by collecting formation, regarding services that are offered, from as many area houses of worship and organizations as possible such information will become a part of the City's website, and then an App will be developed, with regular and timely updates of this information. Director Trader recognizes the importance of recreation (as well as exercise, leisure, and nutrition), and its accompanying health benefits, especially within the African-American community, and in particular, in Annapolis; and how recreation can be an academic catalyst as well as a strategic outlet that can serve to avoid the pitfalls that lead to addiction and incarceration.

**Mr. William F. Rowel**  
**Boards and Commissions**

Mr. Rowel is very gifted with multi-generational roots in Annapolis. He has traveled and resided in many parts of the United States (and the world)—from Annapolis, to Utah, to California, and back to Annapolis, among others. He is a graduate of Howard University. Since the inception of the Mayor's new administration, he has served as the City's Public Engagement and Community Relations Director,

and Senior Advisor, in the Office of the Mayor, which also includes working with and/or assisting with “staffing” the City’s Boards and Commissions. He also serves as the Mayor’s representative on the “Annapolis Collaborative for Change, Safe and Thriving Communities’ Guiding Coalition/Planning Action Team”, which oversees the administration of a \$700,000+ grant from the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP), awarded to the County’s Partnership for Children, Youth, and Families, which focuses on residents in public and subsidized housing communities only within the jurisdictional boundaries of Annapolis (specifically excluding those public and subsidized housing communities in the County) well over 90% of its residents being African-American. As such, these responsibilities and projects are varied, impactful, and wide- and far-reaching all being significant components of the Mayor’s “One Annapolis” initiatives. Nevertheless, Mr. Rowel’s global background provides him with a unique, eclectic, historical, and philosophical lens that views Annapolis’ issues as a microcosm that requires a quest for knowledge and the truth.
