**A RESOLUTION** concerning

**Fiscal Year 2025 Sewer Fees Update**

**FOR** the purpose of updating City of Annapolis sewer fees as recommended by the City's rate consultant; and generally dealing with the FY 2025 fees schedule.

**WHEREAS,** Section 6.16.050 of the City Code requires that concurrent with the submission of the proposed annual budget, the Mayor shall submit to the City Council a proposed schedule of fees.

**WHEREAS,** The City Council adopted the FY 2025 fees schedule on June 10, 2024, but the fees for sewer have been calculated differently by the City's rate consultant;

**NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Fiscal Year 2025 fees schedule be amended as follows:
