13 **A RESOLUTION** concerning

15 **State of Emergency**

17 **FOR** the purpose of further extending the termination date of the Declaration of State of
18 Emergency for the City of Annapolis that was issued on March 12, 2020.

21 **WHEREAS,** on March 12, 2020, in accordance with Section 11.48.030.A of the Annapolis City
22 Code, the Mayor issued a Declaration of State of Emergency due to the ongoing
23 federal and state warnings regarding illness and deaths resulting from exposure to
24 the COVID-19 virus existing on March 5, 2020, within the United States of
25 America; and

27 **WHEREAS,** the Mayor's Declaration of State of Emergency was for a period of 30 days and
28 terminated on April 11, 2020; and

29
30 **WHEREAS,** on April 6, 2020, the City Council adopted R-24-20, which extended the Mayor's
31 Declaration of State of Emergency for an additional period of 30 days to terminate
32 on May 11, 2020; and

33
34 **WHEREAS,** on May 11, 2020, the City Council adopted R-28-20, which extended the Mayor's
35 Declaration of State of Emergency for an additional period of 30 days to terminate
36 on June 11, 2020; and

37
38 **WHEREAS,** on June 8, 2020, the City Council adopted R-36-20, which extended the Mayor's
39 Declaration of State of Emergency for an additional period of 30 days to terminate
40 on July 11, 2020; and

42 **WHEREAS,** to protect the public health, welfare, and safety, prevent the transmission of
43 COVID-19, control the spread of COVID-19, and save lives, the Mayor finds it
44 necessary to extend the current State of Emergency; and

1 **WHEREAS**, the City Council, pursuant to Section 11.48.030.B consents to extending the State
2 of Emergency until the next City Council meeting that succeeds the 30th day after
3 the Governor of Maryland terminates his State of Emergency and rescinds his
4 Proclamation of a Catastrophic Health Emergency.

6 **NOW, THEREFORE,**
7

8 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the March 12, 2020,
9 Declaration of State of Emergency issued by the Mayor of Annapolis shall be extended until the
10 next City Council meeting that succeeds the 30th day after the Governor of Maryland terminates
11 his State of Emergency and rescinds his Proclamation of a Catastrophic Health Emergency.
