#### **A. Update from the Mayor**

##### **Mayor Gavin Buckley Council Remarks**

**7 p.m. Feb 23, 2020**

**City Council Chambers**

**First off, I want to thank everyone for the birthday wishes and to Alderwoman Pindell Charles for serving as Acting Mayor late last week and over the weekend while my family took me away on a short holiday. I have heard there are downsides to turning 60, but so far, these past five days have been easy.**

**We have a few personnel changes to announce. At the next council meeting, the City will be introduced to Roslyn Johnson, who I have nominated to run the City Department of Recreation and Parks.**

**Roslyn brings a depth of professional recreation and parks experience from her time in Baltimore City, Baltimore County, and at National Capital Parks. I understand she has already begun her one-on-ones with council members and, so far, reports are positive.**

**It is my goal that we seek accreditation for our parks and that we vigorously pursue outside funding to enhance opportunities for our residents and visitors.**

**Outgoing Director Archie Trader has been an asset to the department, especially in his leadership of youth and recreational programming and his contribution to major projects including the new Truxtun Park Pool and the revitalization of the tennis and pickleball courts and other parks and facilities.**

**I thank Archie for service to the city not only as director, but in his past and future work as well.**

Last week while I was away, I got a call from Planning and Zoning Director Michael La Place, who announced his intention to step down next month after serving 11 months here. Director La Place came here from Princeton and he will be heading back to be with his family.

Michael, I am sorry the posting in Annapolis didn't work out, but you deserve high praise for the work you have done over the past year. Thank you.

I'd like to again thank Carl and his family and friends for showing up here today to celebrate his contributions.

As we celebrate Black History Month this year in Annapolis, I'd like to bring to your attention to a few of the special events the City is hosting:

- Earlier this evening we held an artist's reception for Comacell Brown, whose artwork will hang in City Hall for the next few weeks. Thank you Comacell for sharing your talents with us! I encourage people to peruse the exhibit during regular business hours;
- This Saturday from 3 to 7 p.m., is the Maryland Recipe Hunt Collection and Tasting at Pip Moyer Center. It's free and open to the public;
- On February 24, a Black History Month celebration will take place in City Council Chambers and will include music and poetry, special guest speakers and food. That begins at 6 p.m., next Friday and is a ticketed event; please contact my office to register for free tickets.
- Then on Saturday from 2 to 7 pm. again at Pip Moyer Rec Center, we will have the Annapolis 2 Africa event. That's on February 25 and is free and open to the public;
- Every Sunday in February we are presenting historically black churches with special City Council Citations;
- Every day this month on City social media, we have a walking tour of Black History sites around Annapolis; and
- We've got a great video storytelling series. Last week was Moonie Day who talked about his experiences as a singer performing at Carr's Beach back in the day and this week is former Alderwoman Cynthia Carter. These are available on the City's social media channels.

I'd like to thank all our city staff who are working on these events and projects. It is a great way to bring attention to the important contributions of African Americans to both the HISTORY of Annapolis, but also its very bright future!

Next, I'd like for us to take a moment to think about the devastating earthquakes in Turkey and Syria. The death toll is staggering and the scope of loss unimaginable. Rebuilding will take years and the trauma of this will never entirely go away.

We have residents in our community who are of Turkish and Syrian heritage with friends and family in the region. Please know that we are so sorry for your loss and our hearts are with you in your grief.

I would like for us to take a moment of silence to remember those who have been lost.

In Annapolis, we have had four pedestrian vs. car incidents since the new year. Two of those have resulted in loss of life. One is looking at many months of rehabilitation.

In two of those incidents, the drivers fled the scene and police are actively seeking information to find and hold the drivers to account.

We must share the road with bicyclists and pedestrians. If you are behind the wheel, you are responsible for what happens.

My administration has been responsive to the cycling community. We are aggressive in seeking grants and outside funding to make connections to meet the goals of the 2011 bicycle master plan.

You should know that, from the moment we receive one of these grants, it is a multi-year process to get from concept to design, to approval through various city, county, state and sometimes federal agencies, all the way to project funding and construction.

For many of these trails, we are seeking easements from private landowners. Even when these bikeways are completed, drivers will still need to be alert to cyclists and pedestrians using and crossing the road.

Last week we hosted the bicycle symposium where members of the cycling community from around the state visited Annapolis and lobbied state legislators for laws and funding for cycling infrastructure. I was proud to stand alongside them in their efforts.

But please, put down your phones. Pay attention to your driving. You don't want to have a grievous injury or death on your conscience – or on your driving record. Especially as we move into nicer weather when we are much more likely to see folks out on the road. Share the road. It's the right thing to do and it is the law.

The last thing for tonight is the topping out ceremony for our new Hillman Garage. The garage is not yet complete. We are a little more than halfway done. We still anticipate a June reopening.

But what we have reached is the highest vertical point in the construction. The concrete is poured and next week they will remove the tower crane which has stood on the site for almost a year now.

We're getting there and I thank our residents, businesses and visitors for their patience.

At the topping out, I got to walk around the job site. Already, I can see that it is a dramatic improvement. It feels more open and will have all the modern conveniences. From here, the work will involve things like: finishes, painting, electrical, plumbing, and landscaping.

I'd like to share a video of the progress to date.

**2. A CONTRACTOR MAY APPEAL THE DECISION WITHIN 10 WORKING DAYS AFTER RECEIVING A COPY OF THE DECISION.**

**a. THE CONTRACTOR MUST PROVIDE A WRITTEN RESPONSE TO THE CITY’S PROCUREMENT OFFICER.**

**b. WITHIN A REASONABLE TIME AFTER RECEIPT OF THE APPEAL, THE PROCUREMENT OFFICER MAY INVESTIGATE, REQUEST WRITTEN TESTIMONY, OR CONDUCT A HEARING, AS THE PROCUREMENT OFFICER DEEMS NECESSARY FOR THE REVIEW OF THE APPEAL.**

**c. THE DECISION OF THE PROCUREMENT OFFICER ON THE APPEAL IS FINAL AND NOT SUBJECT TO APPEAL.**

**d. IF THE CONTRACTOR DOES NOT APPEAL THE DIRECTOR’S DECISION WITHIN 10 WORKING DAYS AFTER RECEIPT, THE DECISION OF THE DIRECTOR IS DEEMED FINAL AND NOT APPEALABLE.**

**3. IF THE FINAL DECISION OF THE DIRECTOR, OR THE PROCUREMENT OFFICER AFTER APPEAL, IS THAT THE CONTRACTOR HAS VIOLATED THE PROVISIONS OF THIS SECTION AND THAT THE VIOLATION WAS INTENTIONAL, AT THE DISCRETION OF THE DIRECTOR, THE CONTRACTOR, ANY OF THEIR PRINCIPALS, OR ANY FIRM, CORPORATION, PARTNERSHIP, OR OTHER BUSINESS ENTITY IN WHICH THAT CONTRACTOR HAS AN INTEREST, MAY NOT BE AWARDED A CITY CONTRACT AND MAY NOT PERFORM ANY WORK ON ANY CITY CONTRACT FOR ONE YEAR FROM THE DATE OF THE FINAL DECISION. Seconded. CARRIED on voice vote.**

Alderman Schandelmeier moved to amended. Seconded. CARRIED on voice vote.

Alderman Schandelmeier moved to amend O-25-22 as follows:

**AMENDMENT 3:**

**PURPOSE OF AMENDMENT:** To eliminate the Wage Deductions section. On page 6, strike lines 6 through 18 and renumber the sections.

**D. WAGE DEDUCTIONS PERMITTED. A CONTRACTOR MAY MAKE ONLY FAIR AND REASONABLE DEDUCTIONS THAT ARE:**

- 1. REQUIRED BY LAW; AND**
  - 2. AUTHORIZED IN A WRITTEN AGREEMENT BETWEEN THE EMPLOYEE AND THE CONTRACTOR SIGNED AT THE BEGINNING OF EMPLOYMENT THAT:**
    - a. CONCERNS FOOD, SLEEPING QUARTERS, OR SIMILAR ITEMS; AND**
    - b. IS SUBMITTED BY THE CONTRACTOR TO THE DIRECTOR; OR**
    - c. REQUIRED OR ALLOWED BY A COLLECTIVE BARGAINING AGREEMENT BETWEEN A BONA-FIDE LABOR ORGANIZATION AND A CONTRACTOR.**
- Seconded. CARRIED on voice vote.

Alderman Schandelmeier moved to amend O-25-22 as follows:

**AMENDMENT 4:**

**PURPOSE OF AMENDMENT:** Eliminate the 51% goal for local hiring.

On page 11, 11-13, strike " FILL AT LEAST 51% OF NEW JOBS REQUIRED TO COMPLETE THE CAPITAL IMPROVEMENT CONTRACT OR THE CAPITAL PROJECT WITH" and after "efforts to" insert "HIRE".

**B. LOCAL HIRING. A CONTRACTOR SHALL MAKE BEST EFFORTS TO FILL AT LEAST 51% OF NEW JOBS REQUIRED TO COMPLETE THE CAPITAL IMPROVEMENT CONTRACT OR THE CAPITAL PROJECT WITH HIRE CITY OF ANNAPOLIS OR ANNE ARUNDEL COUNTY RESIDENTS.** Seconded. CARRIED on voice vote.

Alderman Schandelmeier moved to amend O-25-22 as follows:

**AMENDMENT 5:**

**PURPOSE OF AMENDMENT:** Clarifying that Prevailing Wage document requests must be made as required in the Public Information Act Request section of the city code. On page 8 strike lines 26-28 and on page 9 strike lines 1-2. On Page 8 in line 26 insert subsection "6", "Provisions of Title 6 § 08.081 are subject to the Maryland Public Information Act and requirements of Title 2 § 62, the Public Information Act Requests section of the City code."

**SECTION 12.32.141 - RESERVED RESIDENTIAL DISABLED PARKING NEAR RESIDENCE.**

**A. PURPOSE. THIS SECTION ALLOWS THE CITY TO PROVIDE TEMPORARY RESERVED PARKING FOR ANNAPOLIS RESIDENTS WHO RECEIVE TEMPORARY HANDICAPPED PARKING PLACARDS FROM THE STATE OF MARYLAND, WHICH REQUIRES PARKING NEAR RESIDENCES FOR PERMANENTLY HANDICAPPED STATE RESIDENTS BUT NOT TEMPORARILY HANDICAPPED RESIDENTS.**

**A.B. DEFINITIONS**

**1. "DIRECTOR" MEANS THE CITY MANAGER OR THEIR DESIGNEE FROM A CITY DEPARTMENT OR CITY CONTRACTOR.**

**2. "TEMPORARY DISABILITY" MEANS A DISABILITY AS DEFINED BY A CERTIFIED PHYSICIAN AND COMPLYING WITH HANDICAPPED PARKING PLACARD REQUIREMENTS IN MARYLAND TRANSPORTATION CODE TITLE 13 § 616.2.**

**B.C. ESTABLISHMENT OF TEMPORARY RESERVED RESIDENTIAL PARKING FOR THE TEMPORARILY DISABLED.**

**1. APPLICATION REQUIREMENTS. AN APPLICATION FOR A TEMPORARY RESERVED PARKING SPACE FOR PERSONS WITH DISABILITIES IN THE PUBLIC RIGHT-OF-WAY IN RESIDENTIAL AREAS MUST PROVIDE THE FOLLOWING CRITERIA IN ORDER TO BE CONSIDERED:**

**a. A STATE OF MARYLAND-ISSUED PLACARD OR LICENSE PLATE FOR TEMPORARY DISABILITY AS ISSUED BY THE MARYLAND DEPARTMENT OF TRANSPORTATION MOTOR VEHICLE ADMINISTRATION (MVA) AND SHALL PROVIDE A COPY OF THE MEDICAL CERTIFICATION SUBMITTED TO THE DEPARTMENT OF MOTOR VEHICLES, OR A NEW SUCH CERTIFICATION, WHICH DEMONSTRATES ELIGIBILITY FOR A**

**DMV DISABLED PARKING LICENSE PLATE OR PLACARD; AND**

**b. PROOF OF RESIDENCY AT AN ADDRESS IN THE CITY OF ANNAPOLIS; AND**

**c. PROOF THERE IS NO OFF-STREET PARKING AT THE APPLICANT'S RESIDENCE, OR THE APPLICANT MUST DEMONSTRATE THAT EXISTING OFF-STREET PARKING IS NOT FEASIBLE FOR USE BY THE APPLICANT; AND**

**d. SHOW THERE IS A LEGAL PARKING SPACE IN FRONT OF THE ADDRESS; AND**

**e. DEMONSTRATE THAT A VEHICLE IS REGISTERED IN THE CITY OF ANNAPOLIS TO A PERSON WHO RESIDES AT THE ADDRESS REQUESTED; AND**

**f. PAY A FEE TO BE DETERMINED BY THE DIRECTOR TO COVER THE PROGRAM'S COSTS OF THE PROGRAM.**

**2. APPROVAL REQUIREMENTS. THE DIRECTOR MUST DETERMINE THAT LEGAL PARKING IS AVAILABLE IN FRONT OF THE APPLICANT'S ADDRESS, UNDER THE FOLLOWING CONDITIONS:**

**a. THE OWNER OF THE PROPERTY IN FRONT OF WHICH THE RESERVED SPACE IS PROPOSED TO BE LOCATED HAS CONSENTED, IN WRITING, TO SUCH LOCATION; AND**

**b. THERE IS NO:**

**i. FIRE HYDRANT;**

**ii. CITY NO-PARKING REGULATION; OR**

**iii. OTHER SIMILAR IMPEDIMENTS TO PARKING IN FRONT OF THE APPLICANT'S ADDRESS; AND**

**c. THE APPLICANT'S PROPERTY IS OF INSUFFICIENT WIDTH TO ACCOMMODATE THE RESERVED SPACE; AND**

**d. THE APPLICANT DEMONSTRATES TO THE SATISFACTION OF THE DIRECTOR THAT THE APPLICANT OTHERWISE MEETS THE CRITERIA.**

**3. WAIVERS. IF AN APPLICATION FAILS TO MEET ANY OF THE CRITERIA, IT WILL NOT BE APPROVED UNLESS A WAIVER IS SOUGHT AND APPROVED BY THE DIRECTOR. IF THE APPLICATION IS DENIED, THE APPLICANT SHALL BE NOTIFIED IN WRITING AS TO THE SPECIFIC REASONS FOR THE DENIAL AND SHALL ALSO BE NOTIFIED OF ANY RIGHT TO APPEAL PROVIDED UNDER THIS SECTION. THE DIRECTOR MAY IMPOSE SUCH CONDITIONS ON ANY WAIVER AS THE DIRECTOR DEEMS REASONABLE.**

**4. 2. CREATION OF RESERVES SPACE. ONCE APPROVED, THE CITY**



SHALL INSTALL SIGNS MARKING THE SECTION RESERVED FOR TEMPORARY RESIDENTIAL DISABLED PARKING WITH THE FOLLOWING CONDITIONS:

A. THE NUMBER ON THE SIGN SHALL MATCH THE NUMBER OF THE DESIGNEE'S MVA-ASSIGNED PLACARD;

B. THE SPACE SHALL BE OF ENOUGH SIZE TO FIT THE DESIGNEE'S VEHICLE ONLY. LARGE ENOUGH TO FIT THE DESIGNEE'S VEHICLE, BUT ONLY THEIR VEHICLE;

C. THE SPACE IS FOR TEMPORARY USE ONLY DURING THE DURATION OF THE DISABILITY; IF THE DISABILITY BECOMES PERMANENT, THE DESIGNEE MUST APPLY FOR PERMANENT HANDICAPPED PARKING THROUGH THE STATE.

5. 3. USE OF RESERVED SPACES. THE CITY-DESIGNATED RESERVED RESIDENTIAL PARKING FOR A DISABLED RESIDENT IS RESERVED FOR THE EXCLUSIVE USE OF THE APPROVED APPLICANT.

A. ONLY A VEHICLE WITH THE DESIGNATED PLACARD SHALL PARK IN THE RESERVED SPACE, AND THE PLACARD NUMBER MUST MATCH THE CITY-INSTALLED SIGN AT THE RESERVED SPACE.

B. THE APPLICANT'S VEHICLE IS EXPECTED TO USE THE RESERVED SPACE WHEN PARKED IN THE NEIGHBORHOOD.

C. RESERVED SPACES ARE NOT INTENDED FOR USE BY COMPANIONS EXCEPT WHEN TRANSPORTING PERSONS WITH DISABILITIES AND DISPLAYING A MVA PLATE OR PLACARD WITH THE SAME NUMBER AS ON THE SIGN OF THE DESIGNATED SPACE.

D. USE OF THE PARKING SPACE BY OTHER PERSONS WHEN NOT TRANSPORTING THE PERSON WITH A DISABILITY IS A PARKING VIOLATION THAT CARRIES A \$100 TO \$500 FINE.

6. 4. ADMINISTRATIVE PROCEDURES. ALL APPLICATIONS MUST BE SUBMITTED TO THE DIRECTOR FOR CONSIDERATION AND REVIEW. THE DIRECTOR SHALL:

A. THE DIRECTOR SHALL:

i. EVALUATE ELIGIBILITY CRITERIA; AND

ii.a. VERIFY THE VALIDITY OF THE DISABLED PARKING LICENSE PLATE OR PLACARD; AND

iii. b. VERIFY VEHICLE REGISTRATION; AND

iv. c. CONFIRM RESIDENCY;

v. d. DETERMINE AVAILABILITY OF OFF-STREET AND ON-STREET PARKING; AND

vi. ENSURE CONFORMANCE TO THE TERMS OF THIS SECTION IN MAKING A DECISION.

b. CHALLENGES THAT AN EXISTING OFF-STREET PARKING SPACE IS NOT FEASIBLE FOR USE BY THE APPLICANT DUE TO A LACK OF AVAILABLE SPACE ON THE BLOCK SHALL BE SUBMITTED TO THE DIRECTOR FOR REVIEW;

c. THE DIRECTOR SHALL IMPLEMENT PROCEDURES TO ENSURE THE CONFIDENTIALITY OF ANY MEDICAL INFORMATION SUBMITTED BY AN APPLICANT, INCLUDING MVA MEDICAL CERTIFICATIONS, WHICH SHALL AT MINIMUM PROVIDE FOR THE MAINTENANCE OF SUCH INFORMATION IN A SEALED FILE, WITH ACCESS PERMITTED ONLY TO THE DIRECTOR

AND CERTAIN CITY EMPLOYEES ON A NEED-TO-KNOW BASIS; MEDICAL INFORMATION SUBMITTED BY AN APPLICANT IS EXEMPT FROM MANDATORY DISCLOSURE UNDER FREEDOM OF INFORMATION ACT (FOIA) REQUESTS, AND SHALL NOT BE SUBJECT TO DISCRETIONARY RELEASE.

d. ONCE A DECISION HAS BEEN MADE ON AN APPLICATION, ACCESS SHALL BE PERMITTED ONLY ON THE WRITTEN AUTHORIZATION OF THE DIRECTOR OR ACTING DIRECTOR.

**D. REVOCATION.**

**1. A RESERVED SPACE IS SUBJECT TO REVOCATION AS FOLLOWS:**

**a. IN THE EVENT THAT A COMPLAINT IS MADE TO THE DIRECTOR THAT:**

**I a. THE APPLICANT NO LONGER SATISFIES THE ELIGIBILITY CRITERIA; OR**

**li b. THE SPACE IS BEING REPEATEDLY USED IN A MANNER CONTRARY TO THE AGREEMENT IN TITLE 12 § 32.141(C). BY PERSONS RESIDING IN OR VISITING THE APPLICANT'S HOUSEHOLD.**

**b. THE DIRECTOR WILL CONDUCT A PRELIMINARY INQUIRY TO DETERMINE IF THE COMPLAINT IS SUPPORTED BY SUBSTANTIAL AND CREDIBLE EVIDENCE.**

**c. IF THE DIRECTOR FINDS BY CLEAR AND CONVINCING EVIDENCE THAT THE SPACE IS BEING REPEATEDLY USED IN A MANNER CONTRARY TO THE AGREEMENT BY PERSONS RESIDING IN OR VISITING THE APPLICANT'S HOUSEHOLD:**

**i. THE APPLICANT WILL BE NOTIFIED IN WRITING OF THE NATURE AND SPECIFICS OF THE COMPLAINT AND MUST PROVIDE A RESPONSE WITHIN 45 DAYS TO THE CITY MANAGER OR DESIGNEE.**

**ii. THE APPLICANT AND COMPLAINANT(S) SHALL HAVE THE RIGHT TO APPEAR BEFORE THE DIRECTOR, UPON 15 DAYS' WRITTEN NOTICE OF THE TIME AND PLACE OF THE HEARING, AND BE HEARD IN PERSON OR BY COUNSEL, BUT SUCH HEARING SHALL BE CONDUCTED IN AN INFORMAL MANNER.**

**d. 2. THE DIRECTOR SHALL REVOKE A RESERVED PARKING SPACE DESIGNATION IF THE DIRECTOR FINDS BY A PREPONDERANCE OF THE EVIDENCE THAT THE APPLICANT DID NOT, OR DOES NOT CONTINUE TO, MEET THE REQUIRED CRITERIA IN TITLE 12 § 32.141(C).**
