

PETITION

Rationale: The growing number of restaurants and night spots in the Arts and Entertainment District on Inner West Street has made parking for the Residents of The Murray Hill Residents (Special Residential Parking District 3) increasingly difficult during the evening hours.

Approximately 60% of the households included in our petition lack off-street parking, and there are no viable alternatives for parking within walking distance. In the interest of continuity and fairness, numerous streets that border West St. and the Business District already have the more restricted hours that we are requesting.

Thus, we request that the hours of Residential Parking for the following streets be extended to include the entire period between the hours of 8:00am to Midnight, 7 days per week: these are the same hours currently stipulated in Chapter 12.132.170.C for Dean St., Shaw St., City Gate Lane, Water St., Larkin St., and German St. in Special District 3.

Petition: We, the undersigned residents of Murray Hill and Special Parking District 3 request that the City of Annapolis amend the City Code Chapter 12.32.170 to limit parking on Colonial Ave., Morris St., Murray Ave., and Lafayette St (between West St. and Southgate St.) to 2 hours between the hours of 8:00am and Midnight, 7 days per week, unless the vehicle parked within this district displays the Special Residential Parking Permit for District 3.
