#### A. Update from the Mayor

Mayor Gavin Buckley City Council Meeting Remarks

Council Chambers , June 17, 2019 7 p.m.

Thank you everyone, for being here tonight.

Tonight should be our last night to work on the City's budget forecast for 2019-2020. I know everyone here has worked very hard - including 12 hours last Monday on amendments where everybody got a little of what they wanted, and a little of what they didn't. Not everyone got everything they wanted and that is the nature of compromise.

Throughout this budget, I think Teresa Sutherland burned up a couple of adding machines to get us here. Thank you Teresa. You're a tough cookie and your job isn't easy, but your perseverance is a benefit to the residents and to this council.

Teresa has some number crunchers who also have left a few charred calculators here in City Hall. Jodee Dickinson, our Finance Director who has more than two decades of experience. Thank you for agreeing to work for the residents of our great city. You're doing a great job and I for one want to take this time to recognize your contribution. Cheers!

Another on this list is Katie Connolly, who is the senior accountant for the City. Thank you Katie!

Let's give all three of these smart and powerful women a round of applause for the amazing work they have done!

Teresa has also been involved intimately in another priority - finding a new police chief. I wanted to give you a status update on that. We told folks that it would be about a 90 day process which is where we are right now. As you know in April and May we held meetings to help determine community priorities for hiring a new chief. We convened an interview panel of eight diverse individuals from civilian and law enforcement backgrounds to write the job description and formulate interview questions.

The panel received 61 applications. From there, 13 were interviewed after having met the necessary qualifications. The panel conducted the interviews and narrowed the names for consideration. I'm interviewing candidates this week and we should have something for you very soon. I am appreciative of the panel and their efforts to see this through. I'm appreciative of the people who put their names forward.

That we had so many strong qualified candidates to choose from is a testament to the ability of the City of Annapolis to attract quality people to work for our residents.

My thanks to Teresa, Chief Lisa Myers, Deputy Chief Kevin Simmons, Chuck Howard, Lon Powell, Rev. Stephen Tillett and Elizabeth Alex for serving on the panel.

The Mayor's Office along with Theresa Wellman, Community Development Manager for the City's Planning Department, the Housing and Human Welfare Committee and the Human Relations Commission held a public hearing last week to identify barriers to fair and affordable housing in the City of Annapolis for protected populations.

This public hearing was an opportunity for constituents to become better informed about housing data, affordable housing opportunities, zoning and to review proposed policy.

The event was chaired by Alderman Marc Rodriguez and moderated by William Rowel from my office. Each policy goal was shared along with an accompanying strategy to achieve the goal. Members of the audience gave feedback on each goal as well.

There will be follow up meetings to assess how Annapolis is faring in providing fair housing opportunities and options to residents. I invite you to participate.

School let out for the summer last week. To help promote safe summer priorities,

I attended last week's Caucus of African American leaders at Wiley Bates where I was invited to speak on the issue of gun violence and then we went around back to the ball fields for a tribute to the local artist Edward Montre Seay, who was known locally as "Tre Da Kid." He was shot on Forest Drive a little over a week ago.

On Thursday, I, along with members of my staff, attended the event at Asbury United Methodist Church with the group ACT/Do Not Stand Idly By. Along with Anne Arundel County Executive Steuart Pittman and other elected officials, we signed a pledge to work to end gun violence and to support fair housing practices.

As I said at those two events -- and again on Saturday, where hundreds of people came out to a memorial service to celebrate Montre's too-short life:

As public servants we have a responsibility to look for ways to end gun violence. We have to look for innovative ways to provide all our communities with opportunities toward economic and social mobility. We have to create opportunities to present young people with different ways to resolve conflict.

It is my hope that this body can use its considerable power in the day-to-day affairs of City government to be mindful about making meaningful change in that direction toward peace, health and prosperity in our town.
