22 **FOR** the purpose of authorizing the filing of an application with the Maryland Transit  
23 Administration of the Maryland Department of Transportation for a Sections 5303, 5304,  
24 5307, 5309, 5310, 5311, 5316, and/or 5317 grant(s) under the Federal Transit Act for a  
25 total amount of \$2,661,028 (\$1,870,162 for fixed route transit operations; \$247,776 for  
26 ADA complementary paratransit services; \$315,000 capital grant for transit vehicle  
27 maintenance; \$12,878 capital grant for maintenance equipment, and \$215,212 capital  
28 assistance for transit support vehicle replacement).

32 **WHEREAS,** the Maryland Transit Administration is the designated recipient in Maryland for  
33 grants under the Federal Transit Act; and

35 **WHEREAS,** the Administrator of the Maryland Transit Administration of the Maryland  
36 Department of Transportation is authorized to make grants to counties and to  
37 local governments for public transportation programs or projects; and

39 **WHEREAS,** the contract for financial assistance will impose certain obligations upon the  
40 applicant, including the provision by it of the local share of the project costs in  
41 the program; and

43 **WHEREAS,** it is required by the United States Department of Transportation in accordance  
44 with the provisions of Title VI of the Civil Rights Act of 1964 that, in  
45 connection with the filing of an application for assistance under the Federal  
46 Transit Act, the applicant give an assurance that it will comply with Title VI of

1 the Civil Rights Act of 1964 and the United States Department of  
2 Transportation requirements thereunder; and

4 **WHEREAS,** it is the goal of the applicant that minority business enterprise be utilized to the  
5 fullest extent possible in connection with this project, and that definite  
6 procedures shall be established and administered to ensure that minority  
7 business shall have the maximum construction contracts, supplies, equipment  
8 contracts, or consultant and other services.

10 **NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the  
11 filing of the application referred to above is hereby endorsed.  
12

13 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the  
14 City Council hereby endorses this resolution, thereby indicating approval thereof.

16 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that a copy  
17 of this resolution be sent to the Maryland Transit Administration of the Maryland Department of  
18 Transportation.
