32 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
33 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

35 **Title 20 - SUBDIVISIONS**

36 **Chapter 20.30 - MODERATELY PRICED DWELLING UNITS**

37 **Section 20.30.070 - Affordable housing trust fund.**

38  
39 A. The affordable housing trust fund shall be used to provide homeownership  
40 opportunities to eligible persons or households under [Section 20.30.020](#).

41  
42 B. The fund shall be administered by the Department of Planning and Zoning in  
43 accordance with this chapter and funds shall only be available for use by government  
44 agencies who may contract with nonprofit developers.

1 C. Any affordable housing trust fund monies received shall be placed in a segregated  
2 account and shall be used to provide funds to:

- 3 1. Purchase land and or buildings for other affordable housing that would be
- 4 provided to persons that meet the eligibility criteria for purchasing or renting
- 5 Moderately Priced Dwelling Units (MPDUs);
- 6 2. ~~Provide~~ Contribute to settlement expense, down payment, and mortgage write
- 7 down assistance to eligible persons or households;
- 8 3. Construct for sale housing units;
- 9 4. Purchase and or rehabilitate rental housing for conversion to homeownership;
- 10 5. Rehabilitate residential units including owner occupied residential units;
- 11 6. ~~Provide funds to m~~Match other State or Federal housing programs;
- 12 7. ~~Provide funds for~~ Pay for administrative costs;
- 13 8. Contract with nonprofit developers for development of housing units for sale
- 14 to eligible low or moderate income buyers.

15 **9. GRANT RENTAL ASSISTANCE TO ELIGIBLE PERSONS OR**  
16 **HOUSEHOLDS.**

18 D. THE DEPARTMENT OF PLANNING AND ZONING IS HEREBY AUTHORIZED TO  
19 PROMULGATE SUCH RULES AND REGULATIONS AS ARE NECESSARY TO  
20 IMPLEMENT THE REQUIREMENTS OF THIS CHAPTER.

24 **ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
