11 **A RESOLUTION** concerning

12 **Director of Central Services--Matthew H. Flinner**

14 **FOR** the purpose of expressly confirming the appointment of Matthew Flinner as Director of
15 Central Services; and consenting to compensate the Director of Central Services.

17 **WHEREAS**, Pursuant to § 3.08.030(F), the appointment and initial salary of the Director of
18 Central Services is subject to confirmation by the City Council; and

20 **WHEREAS**, Matthew H. Flinner is coming to the City of Annapolis from Harrisburg,
21 Pennsylvania, where he is chief of staff of the Pennsylvania Department of General
22 Services, a state government agency with 1,000+ employees managing \$4 billion
23 in annual state spending, where his duties include oversight of the state's capital
24 and real estate projects, fleet vehicle and parking operations, procurement, facilities
25 maintenance, and the 45-acre Pennsylvania Capitol Complex; and

27 **WHEREAS**, Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a
28 thorough review of Mr. Flinner's qualifications and determined in her professional
29 opinion that Mr. Flinner's qualifications exceed the minimum requirements of the
30 Annapolis Charter and that Mr. Flinner, by virtue of his background, education and
31 experience, is more than qualified to hold the position of Director of Central
32 Services; and

34 **WHEREAS**, Pursuant to the foregoing City Code provision, the City Council is required to
35 expressly consent to the confirmation and compensation of the Director of Central
36 Services.

38 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the
39 Human Resources Manager for the City of Annapolis, Tricia Hopkins, conducted a comprehensive
40 review of Mr. Flinner's qualifications and has determined that:

- 1 1. Mr. Flinner's qualifications exceed the minimum requirements outlined in the Annapolis
2 City Charter; and
- 3 2. Mr. Flinner's experience make him exceptionally qualified for the position of Director of
4 Central Services.

6 **BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City
7 Council expressly confirms the appointment of Mr. Flinner to the position of Director of Central
8 Services and consents to compensate Mr. Flinner as Director of Central Services in the amount
9 of \$174,536 per annum.
