RE: The Appointment to the Board of Supervisors of Elections

On January 2, 2014 a memo was sent to the Chairs of the Annapolis Democratic and Republican Central Committees regarding Article II, Sec. 6. Board of Supervisors of Elections stating the following:

"Before appointing any supervisors of election, the city council shall request the city central committees representing the two (2) leading political parties of the state in the city each to designate at least four (4) eligible candidates for the position to be filled, **by the second Monday in March (3/10/14)**. If a city central committee fails to nominate the required number of candidates as provided herein, the mayor shall submit a list of nominees to the city council in addition to the central committee's list by the first Monday in April (4/7/14). The city council shall appoint the supervisors by the second Monday in April (4/7/14)."

The information should be submitted to the City Clerk's Office no later than 4:30 on **Monday, March 10, 2014**.

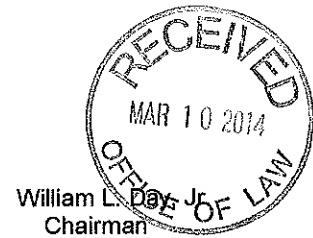
