22 **FOR** the purpose of adopting a capital budget for Fiscal Year 2018; and appropriating funds
23 for expenditures for the Fiscal Year 2018 capital budget.

25 **WHEREAS,** pursuant to Section 6.16.030 of the Annapolis City Code, on April 3, 2017, the
26 Mayor submitted to the City Council a capital budget for the ensuing fiscal year
27 and a capital improvement program for the ensuing five fiscal years; and

29 **WHEREAS,** O-22-17 was referred to the Planning Commission, which held a meeting after
30 proper public notice, to receive evidence and testimony as it judged to be
31 relevant to the consideration of the capital budget and capital improvement
32 program; and

34 **WHEREAS,** on _____, 2017, the Annapolis City Council held a public
35 hearing on the capital budget for the City of Annapolis for Fiscal Year 2018;

38 **WHEREAS,** the attached capital improvement budget for Fiscal Year 2018 is submitted to
39 the Annapolis City Council for its consideration and approval.

43 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS**
44 **CITY COUNCIL** that pursuant to Section 6.16.030 of the Annapolis City Code, the capital
45 budget for Fiscal Year 2018, attached to this ordinance and made a part hereof, be and the same
46 is hereby adopted and approved.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that funds for all expenditures for the purposes specified in the capital budget for Fiscal Year 2018 are hereby appropriated in the amounts therein specified and will be used by the City in the sums itemized in said budget hereby adopted for the principal objectives and purposes thereof, and the total sum of funds herein provided for the respective departments and major operating units thereof, boards, commissions and agencies.

SECTION III: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this Ordinance shall take effect on July 1, 2017.
