20 **Amendment to FY 2018 Fees Schedule**

22 **FOR** the purpose of establishing a Temporary Special Class C Alcoholic Beverage
23 License Fee for Theaters.

24
25 **WHEREAS**, pursuant to Section 6.16.050, the proposed annual budget and schedule of
26 fees was approved by the Mayor and City Council effective July 1, 2017;
27 and

29 **WHEREAS**, it is not economical for a club that is also a 501(c)(3) organization that
30 presents performances in small theaters to pay the current fee; and

32 **WHEREAS**, other Maryland jurisdictions have adopted special fees for similar groups;
33 and

35 **WHEREAS**, Ordinance 46-17 amends Section 7.12.330 of the Code of the City of
36 Annapolis to establish a Temporary Special Class C Alcoholic Beverage
37 License to eligible Theaters; and

39 **WHEREAS**, Resolution 30-17 establishes the fee for licenses issued pursuant to Section
40 7.12.330.F.

42 **NOW THEREFORE,**

 2 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the FY 2018 Fees
 3 Schedule shall be amended by adding a new category for a club that is also a charitable
 4 501(c)(3) organization to obtain One-day Class C Theater Licenses for beer, wine and
 5 liquor for \$5.00 per day for a maximum total annual amount of \$100.00 for theatrical
 6 performances by live actors on a stage.
