21 **Compensation of the Mayor, Aldermen/Alderwomen and City Manager**

22
23 **FOR** the purpose of specifying compensation and allowances to be paid to the Mayor
24 and Aldermen/Alderwomen for the term of office commencing on the first
25 Monday in December, 2017; and for specifying compensation and allowances to
26 be paid to the City Manager.

28 **BY** repealing and re-enacting with amendments the following portions of the Code of
29 the City of Annapolis, 2016 Edition:
30 Section 3.08.030

32 **WHEREAS,** on December 12, 2016, in accordance with the provisions of Article II,
33 Section IV of the Annapolis City Charter, the City Council appointed a
34 Council Compensation Commission via R-29-16 to review the
35 compensation and allowances to be paid to the Mayor and
36 Aldermen/Alderwomen during the terms of office commencing on the first
37 Monday in December 2017, and compensation and allowances to be paid
38 to the City Manager; and

40 **WHEREAS,** on January 9, 2017 pursuant to the Annapolis City Charter, Article II,
41 Section 4(b)(2), the Council Compensation Commission submitted its
42 report containing recommendations on compensation for the Mayor,
43 Aldermen/Alderwomen and the City Manager; and

1 **WHEREAS**, on January 23, 2017, pursuant to the Annapolis City Charter, Article II,
2 Section 4(b)(3), a public hearing was held regarding the Commission's
3 recommendations.

5 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS**
6 **CITY COUNCIL** that the Code of the City of Annapolis shall be amended to read as
7 follows:

9 **Title 3 – HUMAN RESOURCES**

11 **CHAPTER 3.08 – EXEMPT SERVICE**

12 **3.08.030 - Salary.**

13
14 A. 1. For purposes of setting annual salaries, the following positions in the exempt
15 service are assigned grades in the City's pay plan as indicated:

- 2 2. The salary of the Mayor for the term of office commencing on the first Monday
- 3 in December, ~~2013~~2017, shall be an annual salary of ninety-eight thousand
- 4 dollars and an entitlement to the benefits afforded to the City's exempt service
- 5 employees.
- 6
- 7 3. The salary of each Alderman and Alderwoman for the term of office
- 8 commencing on the first Monday in December, ~~2013~~2017, shall be an annual
- 9 salary of ~~thirteen thousand five hundred~~ FIFTEEN THOUSAND dollars. Each
- 10 Alderman and Alderwoman shall be afforded an annual allowance of one
- 11 thousand five hundred dollars TO BE USED EXCLUSIVELY FOR ~~expenses~~
- 12 ~~related to executing the duties associated with their office; such expenses shall~~
- 13 ~~include the cost of cell phones, postage, correspondence, office supplies, and~~
- 14 education and training. Aldermen and Alderwomen shall participate in the
- 15 Maryland State Retirement and Pension System.
- 16
- 17 4. The salary of the City Manager shall be:
- 18
- 19 i. Salary and Performance Reviews. A base salary for the City Manager
- 20 ranging from ~~one hundred twenty thousand~~ ONE HUNDRED FORTY
- 21 THOUSAND dollars to one hundred eighty thousand dollars per year, with
- 22 incremental increases based upon annual performance reviews conducted by
- 23 the Mayor. The initial base salary shall be fixed within the provided range
- 24 based upon the City Manager's education and employment experience. The
- 25 annual performance review shall be based upon criteria established in
- 26 advance by the Mayor in consultation with the Manager of Human
- 27 Resources. The base salary and increments shall be subject to cost of living
- 28 increases (COLAS) every two years, based upon COLAS awarded to other
- 29 City exempt service employees during the two-year period. The City
- 30 Manager's compensation shall be subject to reduction to the same extent as
- 31 other City exempt service employees, including reductions based upon
- 32 furloughs or similar actions.
- 33 ii. Benefits. The City Manager is entitled to receive the same benefits as other
- 34 City exempt service employees, including but not limited to inclusion in the
- 35 City's health care and retirement plans, in which the City and the employee
- 36 contribute in the same proportion as other City exempt service employees.
- 37 iii. Allowances. The City shall provide the City Manager with a City vehicle,
- 38 or additional compensation to reimburse the use of a personally-owned
- 39 vehicle.
- 40 iv. Severance Pay. Three months' severance pay of salary if a City Manager has
- 41 been removed from the position without cause, but there shall be no
- 42 severance pay if the removal is for cause. Grounds for removal that

1 constitute cause shall be 1) conviction of a felony or a crime of moral
2 turpitude; or 2) malfeasance or misfeasance in office.

4 B. Salary raises for the list of positions included in the table in Section 3.08.030A.1:

5
6 1. Shall be justified by a performance evaluation by the City Manager or the
7 Mayor, whichever is the Appointing Authority, that exceeds the minimum
8 requirements for the position and shall be entirely at the City Manager or the
9 Mayor's discretion, with the exception of those positions listed in Subsection
10 (B)(2) of this Section;

11
12 2. Shall be justified by a performance evaluation by the Department Director that
13 exceeds the minimum requirements for the position for the following positions:

- 14
15 i. Deputy Fire Chiefs,
16 ii. Police Captains,
17 iii. Police Major,
18 iv. Recruitment/Employee Relations Administrator,
19 v. Assistant City Attorney,
20 vi. Public Information Officer and Quartermaster.

21
22 3. Shall not be awarded to an individual more frequently than once per year;

23
24 4. Shall not be for an amount exceeding one pay step in the grade range for the
25 position as set in Subsection (A)(1) of this Section;

26
27 5. Shall not cause an individual's salary to exceed the maximum salary of the
28 assigned grade.

29
30 C. Longevity salary increases awarded to civil service employees shall not be a benefit
31 of the exempt service.

32
33 D. A City employee appointed to a position specified in Subsection (A)(1) of this
34 Section shall be assigned to a salary in the new pay grade which is at a minimum five
35 percent higher than the employee's salary prior to promotion or shall be assigned to
36 the minimum of the new grade, whichever is higher. In no case shall the new salary
37 exceed the maximum salary of the new grade.

39 E. For positions other than those specified in Subsection (B)(2) of this Section, the
40 Mayor or City Manager, whichever is the Appointing Authority, may make an initial
41 appointment at a salary greater than the first step of the assigned grade. The
42 appointment and initial salary is subject to confirmation by the City Council. For
43 those positions specified in Subsection (B)(2) of this Section, appointments made by
44 Department Director do not require City Council approval and initial appointments
45 may be made at a salary greater than the first step of the assigned grade subject to the
46 availability of funding.

F. The Mayor shall report to the City Council on an annual basis the salaries of all positions listed in Subsection A of this Section, and all increases in salary awarded since the prior report.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this Ordinance shall take effect July 1, 2017.
