29 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
30 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

32 **Title 3 - CIVIL SERVICE ADMINISTRATION**

33 **Chapter 3.12 - Civil Service Administration**

34 **Section 3.12.050 - Civil Service Board--Duties.**

36 The Civil Service Board shall be responsible for:

- 37 ~~A. Approving the classification and establishment of minimum qualifications for all~~
38 ~~civil service positions upon the recommendation of the Human Resources Manager.~~
39 ~~Any new or reclassified position that will result in a financial impact to the budget~~
40 ~~shall be subject to funding approval through the annual budget process or the budget~~
41 ~~transfer process defined in Section 6.16.020 of the City Code;~~
42 ~~B. Making recommendations to the City Council as provided in this chapter;~~
