22 **FOR** the purpose of adopting an Amended Citizen Participation Plan as it relates to the
23 administration of the Community Planning and Development programs funded by the
24 U.S. Department of Housing and Urban Development.

26 **WHEREAS,** the Consolidated Plan (CP) and Assessment of Fair Housing (AFH) are
27 documents required by the U.S. Department of Housing and Urban Development
28 (HUD) for jurisdictions to continue to receive federal housing and community
29 development funding; and

31 **WHEREAS,** the City of Annapolis receives Community Development Block Grant (CDBG)
32 funding annually; and

34 **WHEREAS,** the CP examines the housing and community development needs of the City, sets
35 priorities for the CDBG funds, establishes an Annual Action Plan for meeting
36 current and future needs, and identifies the City’s performance in meeting its
37 annual goals through the Consolidated Annual Performance Evaluation Report
38 (CAPER); and

40 **WHEREAS,** the AFH replaces the Analysis of Impediments to Fair Housing (AI) to assist the
41 City in identifying fair housing issues and related contributing factors to achieve
42 comprehensive community development goals and affirmatively further fair
43 housing; and

45 **WHEREAS,** the CP and AFH are also required to have a strategy for resident participation in
46 the planning process; and

WHEREAS, the amended Citizen Participation Plan presents the City’s plan for providing for and encouraging all citizens to participate in the development, revision, amendment, adoption, and implementation of the: (1) Citizen Participation Plan (CPP), (2) Assessment of Fair Housing (AFH), (3) Consolidated Plan (CP), (4) Annual Action Plan (AAP), (5) Consolidated Annual Performance and Evaluation Report (CAPER), and (6) Section 108 Loan Guarantee Program Lead Agency; and

WHEREAS, the Planning and Zoning Department Community Development Division is the lead agency for the administration of the CDBG Program; and

WHEREAS, local jurisdictions, which adopted a citizen participation plan prior to August 17, 2015, are required to amend their plans to comply with new provisions of 24 C.F.R. § 91.105 to include ways for citizens to participate in and comment on the City’s Fair Housing Assessment.

NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the 2017 Amended Citizen Participation Plan as it relates to the administration of the Community Planning and Development programs funded by the U.S. Department of Housing and Urban Development is hereby adopted.
