Remarks – City Special Council

Good afternoon. I have signed a Declaration of State of Emergency. The declaration allows the City to activate the Office of Emergency Management and to render and request mutual aid from other jurisdictions. It also allows the City to seek reimbursements from the state, and now that the federal government has declared a state of emergency, we can be eligible for money from the feds. That money will be important because this will also bring a tremendous financial strain to the City. We will need to tap all available resources. Yesterday, Maryland Governor Larry Hogan put the state at the highest emergency activation level. He activated the Maryland Emergency Management Agency level to full. He activated the National Guard. He prohibited mass gatherings and closed all senior centers in the state. He closed all schools. He set guidance for hospital visitation. He issued an order for mandatory telework for non-essential state employees.

In the aftermath of Gov. Hogan's declaration, I wanted to ensure that the City could follow emergency procedures by activating our Office of Emergency Management and getting all City Department heads together to determine telework and leave policies for staff and to also close City buildings in order to better secure the public health.

We want to try to strike a balance between providing essential government services and continuing to function for the sake of residents, but keeping our City staff safe. People are counting on us to get it right.

The next few weeks will test our unity as a city government and as a community. As we work to contain and mitigate the spread of the virus, we will face many challenges. In fact, I think that this may be one of the most difficult things the City has ever faced. Life in Annapolis may change over the next few weeks and maybe even months. I believe that we can be unified to face this threat, just like we were after 9/11, after countless hurricanes and Nor'easters and the gun violence that has so shaken our City. Indeed this virus, COVID-19, has threatened other parts of the world with a severity that most of us can barely comprehend.

I want to assure you that the City of Annapolis has been working on preparations for just this kind of crisis. Not just over the past few weeks, but over months and even years. We have plans and we have run drills. We have one of the best Office of Emergency Management units in the country. These men and women are smart professionals who put the public health and security of our city above all else.

We have a partner in Anne Arundel County and they are working with us not only to ensure that health professionals that we share with them have what they need to deal with this crisis, but that they are being vigilant about protecting each and every resident of this county and indeed this City.

Today, I want to bring the Council and all residents up-to-date on what we have done and will be doing to protect this community.
