22 **Water Service Agreement – 1049 Chesapeake Harbour Drive**

23
24 **FOR** the purpose of authorizing a water service agreement providing for the extension of City
25 water service to 1049 Chesapeake Harbour Drive located in Anne Arundel County; and
26 matters generally relating to providing said water service outside the City limits.

27
28 **WHEREAS,** the Property Owner is the fee simple owner of an improved parcel of land consisting
29 of approximately 0.9100 acres, more or less, located at 1049 Chesapeake Harbour
30 Road, Annapolis, Maryland 21401, also known as 1049 Chesapeake Harbour
31 Drive, and as more accurately described in a deed recorded at Liber 34599 folio
32 214 among the Land Records of Anne Arundel County (collectively, the
33 “Property”), which is located outside of City limits; and

34
35 **WHEREAS,** the Property Owner currently draws its water supply for the Property from a private,
36 on-site well, which is now failing, and the Property Owner desires to be connected
37 to the City’s water service; and

39 **WHEREAS,** the Property Owner submitted an application to the City pursuant to Chapter 16.04
40 of the City Code, as may be amended, to obtain a permit to connect with the City
41 water utility system to obtain water service for the Property, which Permit is
42 incorporated herein by reference; and

43
44 **WHEREAS,** it is the intention of the City that the City Department of Public Works shall not

1 grant final approval for this connection to the City water utility system until such
2 time as it shall be satisfied that the proposed connection shall not result in or cause
3 an inadequate water flow to the Property or to other properties served by the
4 affected City water utility line and that the proposed connection satisfies other
5 requirements of the Department; and

7 **WHEREAS,** the attached Agreement and the Permit do not include a request for sanitary sewer
8 service; and
9

10 **WHEREAS,** the parties believe it to be in the public's interest to permit the Property Owner to
11 connect to the City water utility system; and
12

13 **WHEREAS,** Section 16.08.050A of the Code of the City of Annapolis requires the passage of a
14 resolution before water service may be extended by written agreement outside of
15 the City limits; and
16

17 **WHEREAS,** pursuant to Section 16.08.050A of the Code of the City of Annapolis the Director
18 of Public Works has issued a determination, and upon same, the City Council
19 hereby finds that existing and/or funded facilities, capacity and infrastructure are
20 sufficient to serve the property in addition to existing and reasonably foreseeable
21 City users.

23 **NOW, THEREFORE,**

24
25 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the Water Service
26 Agreement attached hereto be and the same is hereby approved, adopted and authorized.

28 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this
29 Resolution shall take effect from the date of its passage.
