19 **AN ORDINANCE** concerning

21 **Stanton Center Lease Agreement**

24 **FOR** the purpose of approving the lease for certain City-owned property located at the Stanton  
25 Community Center, 92 West Washington Street , Annapolis, Maryland 21401 between Anne  
26 Arundel Workforce Development Corporation and the City of Annapolis; providing an  
27 effective date; and matters generally relating to said Lease Agreement.

29 **WHEREAS,** the City is the fee simple owner of the property known and described as the Stanton  
30 Community Center, 92 West Washington Street, Annapolis, Maryland 21401, and  
31 he City has space therein to lease; and

32  
33 **WHEREAS,** Anne Arundel Workforce Development Corporation, as a tenant, desires to lease a  
34 portion of the Stanton Community Center, as further described and depicted in the  
35 Lease Agreement attached hereto and incorporated herein; and

36  
37 **WHEREAS,** Anne Arundel Workforce Development Corporation, as a tenant, wishes to lease a  
38 portion of the Stanton Community Center for the purpose of an office for its  
39 Community Workforce Specialist and Youth Career Navigation Specialist; and

41 **WHEREAS,** the parties to desire to enter into this Lease Agreement that defines the rights,  
42 duties, and liabilities of the parties; and

1 **WHEREAS**, Article III, Section 8 of the Charter of the City of Annapolis requires the passage  
2 of an ordinance to authorize the lease of City-owned property.  
3

4 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
5 **COUNCIL** that the Lease Agreement, a copy of which is attached hereto and made a part hereof,  
6 between Anne Arundel Workforce Development Corporation and the City of Annapolis for the  
7 lease of certain municipal property, is hereby approved and authorized.  
8

9 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
10 **ANNAPOLIS CITY COUNCIL** that in accordance with Article III, Section 8 of the Charter of  
11 the City of Annapolis, the proposed leases of City-owned property will better serve the public need  
12 for which the property was acquired.

14 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
15 **ANNAPOLIS CITY COUNCIL** that this Ordinance shall take effect from the date of its passage.
