Manage, direct and oversee all City operations in Maryland's capital city. The City of Annapolis is a full service municipal government, providing fire, planning & zoning, police, public works, recreation & parks, transportation/transit, and utilities services, in addition to all internal support functions.

Directed and oversaw the day-to-day operations of all public works functions. The Department of Public Works has 102 employees and an operating budget of over \$21 million, and is responsible for capital project implementation; water treatment and distribution; wastewater collection; solid waste collection and disposal; facility planning and maintenance; fleet management and maintenance; street repair and maintenance; development review; and storm water management.

Notable accomplishments include:

- Oversaw the design and construction of a new water treatment plant, the City's largest capital project ever and its first major design-build project. The project was awarded a U.S. Green Building Council (USGBC) Maryland 2019 Leadership Award.
- Initiated and managed a 12-megawatt solar energy project, the largest on a closed landfill in the U.S. The plant went into full operation in July 2018.

### **2006-2010**              **CITY OF SAN DIEGO, San Diego, California** ***Deputy Chief Operating Officer***

Responsible for leadership, management, and strategic planning for five City departments, with over 1,900 employees and a \$454.4 million annual budget. Provided policy guidance, legislative assistance, constituent services, and business process management to the Mayor, City Council, and Chief Operating Officer. Maintained a constant focus on outstanding customer service, enhancing public trust, fiscal reform, and recapitalization of the City's facilities and infrastructure.

Noteworthy accomplishments included:

- Oversaw the consolidation of three fleet maintenance divisions (Fire, Police and Public Works) into one effective organization with new performance metrics and an improved management information system.
- Implemented the plan to lease two floors in the iconic \$180 million San Diego Central Library to a charter school for \$20 million prepayment, allowing successful conclusion of fund raising and facility construction.
- Developed the framework for establishing a long-term investment program required to recapitalize and then maintain the City's vast infrastructure assets. Through innovative use of service levels for the infrastructure, the "catch-up" funding needs were determined, along with funding required to maintain the assets at the assigned service level.
- Managed the City's response and recovery efforts after the massive wildfire in October 2007. The City's right-of-way damage was quickly assessed and repaired; building structural evaluations were completed; and erosion control features were quickly installed on burned slopes.
