36	fund may be credited with one-tenth of one percent of the general fund revenues and all
37	funds received by the City for the arts, including visual art in public places, the performing
38	arts and works of art, whether contributed, earned, secured through grants or otherwise
39	obtained. Monies credited to such account shall be expended for acquisition of works of
40	art, maintenance and repair of works of art, production of the performing arts, support of
41	works of art and expenses of administration of this chapter.
