15 **Director of Public Works – David A. Jarrell**

17 **FOR** the purpose of expressly confirming the appointment of David A. Jarrell as the Director of
18 Public Works; and consenting to compensate the Director.

20 **WHEREAS,** pursuant to Section 3.08.030.F of the Annapolis City Code, the appointment and
21 initial salary of the Director of Public Works is subject to confirmation by the City
22 Council; and

24 **WHEREAS,** the Director of Public Works position became vacant on June 23, 2022; and

25
26 **WHEREAS,** Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a
27 thorough review of Mr. Jarrell’s qualifications and determined in her professional
28 opinion that Mr. Jarrell’s qualifications exceed the minimum requirements of the
29 Annapolis Charter and that Mr. Jarrell, by virtue of his background, education and
30 experience, is more than qualified to hold the position of Director of Public Works;

33 **WHEREAS,** pursuant to the foregoing City Code provision, the City Council is required to
34 expressly consent to the confirmation and compensation of the Director of Public
35 Works.

37 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
38 Tricia Hopkins, Human Resources Manager of the City of Annapolis, conducted a thorough review
39 of Mr. Jarrell’s qualifications and determined in her professional opinion that Mr. Jarrell’s
40 qualifications exceed the minimum requirements of the Annapolis Charter and that Mr. Jarrell, by
41 virtue of his background, education, and experience, is more than qualified to hold the position of
42 Director of Public Works.

45 **BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City
46 Council expressly confirms the appointment of Mr. Jarrell to the position of Director of Public

1 Works and consents to compensate Mr. Jarrell as Director of Public Works in the amount of
2 \$180,429 per annum, commencing August 4, 2022.
