26 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
27 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

29 **Title 7 – BUSINESS LICENSES, TAXES AND REGULATIONS**

30 **Chapter 7.43 – STREET CAFÉS**

31 **7.42.010 - Sidewalk café—Defined—Permit required**

33 D. For purposes of this chapter, "sidewalk café" means ~~any area situated on a public~~
34 ~~sidewalk, and, as authorized by a lease with the City, any adjoining public street, where~~
35 ~~food, refreshments, and/or beverages are sold by a restaurant, delicatessen, ice cream~~
36 ~~shop or coffee shop (hereinafter "operating establishment") for public consumption at~~
37 ~~tables or counters located on the sidewalk fronting the operating establishment. Sidewalk~~
38 ~~cafés shall operate only as authorized pursuant to this chapter. any area on the public~~
39 sidewalk:

41 1. adjacent to a food service business where food and/or beverages may be
42 consumed at tables and chairs whether the food and/or beverages are purchased
43 at the table or inside the adjacent city-licensed food service business,

45 2. that is permitted by the city to be a sidewalk café section of the public walkway.

1 E. SIDEWALK CAFÉS SHALL OPERATE ONLY AS AUTHORIZED PURSUANT
2 TO THIS CHAPTER.

5 **ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
