PURPOSE OF AMENDMENT: Exclude maritime districts from most sections of O-9-22

On Page 7 of "Table of off-street parking requirements" in "B1 districts" row after "NONE REQUIRED." add "EXCEPT IN MARITIME DISTRICTS UNDER TITLE 21 § 46.030 THROUGH § 46.050, IN WHICH CASE SPACES EQUAL TO 30% OF CUSTOMER SEATING AND STANDING CAPACITY ARE REQUIRED" and in the "Other provisions" column unstrike "Standing capacity is computed as one person per seven square feet in front of all counter and service areas. Seating capacity is computed as the number of seats provided."

Seating capacity is computed as the number of seats provided.</p>

On Page 8 in "Table of off-street parking requirements" in the "Restaurants with delivery service" row under the "Standard" column after "NONE REQUIRED" add "EXCEPT IN MARITIME DISTRICTS INCLUDED IN TITLE 21 § 46.030 THROUGH § 46.050, IN WHICH ONE ADDITIONAL PARKING SPACE PER DELIVERY VEHICLE OWNED OR LEASED BY THE BUSINESS OWNER AND STORED ON-SITE DURING CLOSING HOURS, PLUS ONE SPACE PER TWO DELIVERY VEHICLES THAT ARE NOT OWNED OR LEASED BY THE BUSINESS OWNER BUT UTILIZED FOR THE DELIVERY SERVICE, IS REQUIRED." and in the "Additional provisions" column unstrike "Spaces shall be based on the maximum number of delivery vehicles used by the business."

Restaurants and Delicatessens		
Restaurants with delivery service	<p>One additional parking space per delivery vehicle owned or leased by the business owner and stored on site during closing hours, plus one space per two delivery vehicles which are not owned or leased by the business owner, but utilized for the delivery service.</p> <p>NONE REQUIRED</p> <p><u>EXCEPT IN MARITIME DISTRICTS INCLUDED IN TITLE 21 § 46.030 THROUGH § 46.050, IN WHICH ONE ADDITIONAL PARKING SPACE PER DELIVERY VEHICLE OWNED OR LEASED BY THE BUSINESS OWNER AND STORED ON-SITE DURING CLOSING HOURS, PLUS ONE SPACE PER TWO DELIVERY VEHICLES THAT ARE NOT OWNED OR LEASED BY THE BUSINESS OWNER BUT UTILIZED FOR THE DELIVERY SERVICE, IS REQUIRED.</u></p>	Spaces shall be based on the maximum number of delivery vehicles used by the business.

On Page 8 in "Table of off-street parking requirements" in the "Social clubs, noncommercial" row in the "Standard" "column strike One space per lodging room (if provided) plus spaces sufficient to serve ~~thirty~~ 15 percent of the capacity in persons of the facility." and replace with "EXCEPT IN MARITIME DISTRICTS INCLUDED IN TITLE 21 § 46.030 THROUGH § 46.050, IN WHICH ONE SPACE PER LODGING ROOM (IF PROVIDED) PLUS SPACES SUFFICIENT TO SERVE 30% OF THE CAPACITY IN PERSONS OF THE FACILITY."

Social clubs, noncommercial	One space per lodging room (if provided) plus spaces sufficient to serve thirty <u>15</u> percent of the capacity in persons of the facility <u>EXCEPT IN MARITIME DISTRICTS INCLUDED IN TITLE 21 § 46.030 THROUGH § 46.050, IN WHICH PARKING SPACE SHALL EQUAL 30% OF THE CAPACITY IN PERSONS OF THE FACILITY.</u>
