- WHEREAS, § 21.46.010 (E) states "If there is an increase in non-maritime uses granted through the above incentives, a fee established by resolution of the City Council and set forth in the fees schedule shall be assessed to the property owner for the purposes

of supporting the Annapolis Maritime Industry Fund and associated programs."; and

**WHEREAS**, R-54-22 establishes the fee for non-maritime uses granted through the water access incentives allowed by the zoning requirements.
