37 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
38 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

1 **2.48.610 - RENT STABILIZATION BOARD.** THERE IS HEREBY CREATED A RENT
2 STABILIZATION BOARD OF THE CITY OF ANNAPOLIS.

3 **A. PURPOSE.** THE RENT STABILIZATION BOARD SHALL:

- 4 1. REVIEW AND CONSIDER RESIDENTIAL RENTAL POLICY IN THE
5 CITY OF ANNAPOLIS; AND
- 6 2. TRACK OVERALL NON-COMMERCIAL, PRIVATE RESIDENTIAL
7 RENTAL RATES; AND
- 8 3. CREATE AN ANNUAL REPORT ON RESIDENTIAL RENTAL RATES
9 AND GUIDELINES IN THE CITY OF ANNAPOLIS

10
11 **B. COMPOSITION AND TERMS.**

- 12 1. MEMBERS OF THE RENT STABILIZATION BOARD SHALL
13 CONSIST OF FIVE MEMBERS, THREE OF WHOM ARE SELECTED
14 BY THE HOUSING AND HUMAN WELFARE COMMITTEE OF THE
15 CITY COUNCIL, AND TWO RESIDENTS OF THE CITY WHO
16 POSSESS A DEMONSTRATED INTEREST IN HOUSING AND
17 RENTER CONCERNS AND WHO SHALL BE APPOINTED BY THE
18 MAYOR AND CONFIRMED BY THE CITY COUNCIL.
- 19 2. EACH MEMBER SHALL SERVE FOR A TERM OF THREE YEARS,
20 OR UNTIL THE MEMBER'S SUCCESSOR IS APPOINTED AND
21 CONFIRMED, COMMENCING ON THE FIRST DAY OF JUNE, THE
22 TERM OF NO MORE THAN ONE MEMBER EXPIRING EACH YEAR
- 23 3. THE BOARD SHALL MEET MONTHLY, AND THE CHAIR MAY
24 CALL SPECIAL MEETINGS.
 - 25 a. THE BOARD SHALL ELECT A CHAIR AND VICE CHAIR
26 WHO SERVE FOR A TERM OF ONE YEAR.
 - 27 b. IF THE CHAIR CAN NOT ATTEND A MEETING, THE VICE
28 CHAIR SHALL SERVE AS ACTING CHAIR FOR THAT
29 MEETING.
- 30 4. THE PUBLISHED AGENDA FOR EACH MEETING MAY BE
31 REVISED BY A MAJORITY VOTE OF THE MEMBERS PRESENT.
- 32 5. ACTION OF THE BOARD SHALL BE BY A MAJORITY VOTE OF
33 THE MEMBERS PRESENT. THREE BOARD MEMBERS SHALL
34 CONSTITUTE A QUORUM FOR THE BUSINESS TRANSACTION.
- 35 6. THE BOARD'S REPORTS SHALL BE ISSUED IN ENGLISH AND
36 SPANISH.

38 **C. RESPONSIBILITIES.**

- 1 1. THE RENT STABILIZATION BOARD SHALL:
- 2 a. CREATE ANNUAL RENT INCREASE GUIDELINES PER
- 3 TITLE 18 § 04.030 IN THE RESIDENTAL RENT GUIDELINES
- 4 SECTION OF THE CODE:
- 5 i. ISSUED NO LATER THAN MARCH 1; AND
- 6 ii. BASED ON THE INCREASE OR DECREASE IN THE
- 7 RESIDENTIAL RENT COMPONENT OF THE
- 8 CONSUMER PRICE INDEX FOR ALL URBAN
- 9 CONSUMERS (CPI-U) FOR THE REGION COVERING
- 10 THE CITY OF ANNAPOLIS UNDER THE MID-
- 11 ATLANTIC REGION AS PUBLISHED BY THE UNITED
- 12 STATES DEPARTMENT OF LABOR STATISTICS, OR
- 13 ANY SUCCESSOR INDEX; and
- 14 iii. PUBLISHED ON THE CITY OF ANNAPOLIS WEBSITE.
- 15 b. RECOMMEND POLICY INITIATIVES AND CHANGES IN
- 16 LAW AND REGULATION TO ACCOMPLISH THE
- 17 OBJECTIVES OF THE CITY COUNCIL REGARDING
- 18 RESIDENTAL RENT STABILIZATION; AND
- 19 c. REPORT COMPLAINTS THAT REQUIRE ACTION TO THE
- 20 CITY MANAGER.

23 **CHAPTER 18.01 - GENERAL PROVISIONS.**

25 **Section 18.01.010 - DEFINITIONS.**

26 THE FOLLOWING TERMS SHALL HAVE THE MEANINGS INDICATED UNLESS

27 A CONTRARY MEANING IS CLEARLY INTENDED FROM THE CONTEXT IN

28 WHICH THE TERM APPEARS:

- 30 A. "CITY MANAGER" MEANS THE ANNAPOLIS CITY MANAGER OR THEIR
- 31 DESIGNEE, WHICH MAY BE A CITY DEPARTMENT OR DEPARTMENT
- 32 DIRECTOR.
- 33
- 34 B. "LANDLORD" MEANS ANY PERSON, PARTNERSHIP, FIRM,
- 35 CORPORATION, OR ANY COMBINATION OF BUSINESS ENTITIES
- 36 ENGAGED IN THE BUSINESS OF LEASING ONE OR MORE DWELLING
- 37 UNIT(S) IN THE CITY.

- 39 C. "RENT", FOR THE PURPOSE OF THIS PROVISION ONLY, SHALL MEAN A
- 40 FIXED PERIODIC COMPENSATION PAID BY A TENANT AT FIXED
- 41 INTERVALS TO A LANDLORD FOR THE POSSESSION AND USE OF
- 42 PROPERTY, INCLUDING ANY AMOUNT PAID TO THE LANDLORD.

2 D. "RENT STABILIZATION BOARD", ALSO REFERRED TO AS "BOARD", IS
3 AS DEFINED IN TITLE 2 § 48.610

5 E. "TENANT" MEANS A PERSON WHO PAYS RENT OR OTHER
6 CONSIDERATION FOR THE USE OF ANOTHER'S PREMISES PURSUANT
7 TO A LEASE AGREEMENT OR SIMILAR ARRANGEMENT.

13 **SECTION 18.04.030 - RENT GUIDELINES.**

- 14 B. **RENT GUIDELINES.** THE RENT STABILIZATION BOARD (TITLE 2 § 48.610)
15 ISSUES ANNUAL RENT INCREASE GUIDELINES NO LATER THAN MARCH 1ST.
16 1. THE GUIDELINE ARE BASED ON THE INCREASE OR DECREASE IN THE
17 RESIDENTIAL RENT COMPONENT OF THE CONSUMER PRICE INDEX
18 FOR ALL URBAN CONSUMERS (CPI-U) FOR THE REGION COVERING
19 THE CITY OF ANNAPOLIS UNDER THE MID-ATLANTIC REGION AS
20 PUBLISHED BY THE UNITED STATES DEPARTMENT OF LABOR
21 STATISTICS, OR ANY SUCCESSOR INDEX.
22 2. RENT INCREASE GUIDELINES ARE PUBLISHED ON THE CITY OF
23 ANNAPOLIS WEBSITE.
24 3. THE BOARD MAY REVIEW ANY RESIDENTIAL RENT INCREASE THAT
25 APPEARS TO BE EXCESSIVE AND ENCOURAGE THE LANDLORD TO
26 REDUCE, MODIFY, OR POSTPONE THE INCREASE.
27

28 **SECTION 18.04.040 - RENT ADJUSTMENTS.**

29 A. **RENT ADJUSTMENTS.**

- 30 1. A LANDLORD SHALL GIVE TENANTS 90 DAYS' NOTICE BEFORE
31 INCREASING RENT.
32 2. A LANDLORD MUST NOT IMPOSE MORE THAN ONE RENT INCREASE
33 ON A TENANT IN ANY 12 MONTHS.
34 3. EACH WRITTEN RENT INCREASE NOTICE MUST CONTAIN THE
35 FOLLOWING INFORMATION:
36 a. THE AMOUNT OF MONTHLY RENT IMMEDIATELY PRECEDING
37 THE EFFECTIVE DATE OF THE PROPOSED INCREASE
38 (OLD RENT); AND
39 b. THE AMOUNT OF MONTHLY RENT OFFERED IMMEDIATELY
40 AFTER THE RENT INCREASE TAKES EFFECT (NEW RENT); AND

- c. THE PERCENTAGE INCREASE OF MONTHLY RENT; AND
- d. THE EFFECTIVE DATE OF THE PROPOSED INCREASE; AND
- e. THE APPLICABLE RENT INCREASE GUIDELINE ISSUED UNDER SECTION § 18.05.020 ABOVE; AND
- f. A NOTICE THAT THE TENANT MAY ASK THE RENT STABILIZATION BOARD (TITLE 2 § 48.610) TO REVIEW ANY RENT INCREASE THAT THE TENANT CONSIDERS EXCESSIVE; AND
- g. OTHER INFORMATION THE LANDLORD DEEMS HELPFUL IN EXPLAINING THE RENT INCREASE.

4. IF THE TENANT DECLINES THE RENT INCREASE:

- a. A LANDLORD SHALL TERMINATE THE LEASE UPON 60 DAYS NOTICE; AND
- b. THE TENANT SHALL VACATE THE PROPERTY AT THE END OF THE NOTICE TERM.

B. RENT INCREASE NOTICE REQUIREMENTS.

1. **WRITTEN NOTICE.** THE LANDLORD SHALL SEND THE WRITTEN NOTICE:

- a. VIA THE U.S. POSTAL SERVICE TO THE TENANT'S DWELLING UNIT; OR
- b. ANOTHER MEANS BY WHICH THE LANDLORD OBTAINS A SIGNED RECEIPT FROM THE TENANT OR THE TENANT'S REPRESENTATIVE.

2. **NOTICE CERTIFICATION.**

- a. THE LANDLORD SHALL CERTIFY THAT THE NOTIFICATION HAS BEEN SENT BY THE FOLLOWING METHODS:
 - i. REGISTERED OR CERTIFIED MAIL RECEIPT; OR
 - ii. AFFIDAVIT DATED AT THE TIME OF MAILING.
- b. THE RECEIPT OR REGISTRATION OF ANY NOTICE SENT BY U.S. CERTIFIED OR REGISTERED MAIL IS PRESUMPTIVE EVIDENCE THAT THE NOTICE WAS DELIVERED TO THE ADDRESS PARTY, AND THE RECEIPT OR REGISTRATION DATE IS THE POSTMARK DATE.
- c. NOTICES MUST BE WRITTEN IN ENGLISH AND SPANISH.

3. **RECORD RETENTION.**

- a. THE LANDLORD SHALL RETAIN A COPY OF THE AFFIDAVIT IN THE LANDLORD'S RECORDS.

- 1 b. THE DAY AFTER THE POSTMARK DATE IS THE DATE OF
2 DELIVERY BY U.S. MAIL FOR THE PURPOSES OF THESE NOTICE
3 REQUIREMENTS.

13 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**
14 **ANNAPOLIS CITY COUNCIL** the City Manager or their designee shall, within 90 days of the
15 effective date of this legislation, promulgate any rules or regulations necessary to implement the
16 intent of this legislation.

17 **SECTION III: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**
18 **ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
