32 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
33 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

35 **Title 21 - PLANNING AND ZONING**

36 **Chapter 21.08 - Decision Making Bodies and Officials**

37 **Section 21.08.030 - Planning Commission.**

39 ~~B. Membership. The Planning Commission shall consist of seven residents of the City who~~
40 ~~have a demonstrated interest with regard to planning policy and with regard to land use~~
41 ~~matters and procedures of the City. The members shall be appointed by the Mayor and~~
42 ~~confirmed by the City Council.~~

43 B. Membership.

44 1. The Planning Commission shall consist of **nine** members:

1 a. Who are City residents and have a demonstrated interest in city planning
2 policy, land use matters, and City procedures; and

3 b. Two members shall be residents of government-subsidized housing or
4 have incomes below the Average Median Family Income for the City as
5 determined by the U.S. Department of Housing and Urban Development's
6 Office of Policy Development and Research.

7 2. The members shall be appointed by the Mayor and confirmed by the City Council.

9 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**
10 **ANNAPOLIS CITY COUNCIL** that this ordinance shall take effect from the date of its passage.
