#### A. Update from the Mayor

Mayor Gavin Buckley, City Council Remarks

Last week Annapolis hosted the inauguration of our new Governor, Wes Moore, Lieutenant Governor Aruna Miller and Comptroller Brooke Lierman. It was a week that showcased our city at its best.

I want to thank and acknowledge everyone who came together to manage these important,

logistically challenging events. In particular, thank you to the governor's staff, state police and many other state teams and officials for their cooperation with our Annapolis public safety team.

I'd especially like to mention the City of Annapolis director of the Office of Emergency Management, Kevin Simmons who provided leadership and coordination from the City. I'd also like to acknowledge Annapolis Police and Fire. Many of our officers and staff were dispatched to handle road closures, parking restrictions, security, and more.

Also, can we all take a moment to note that Oprah herself is a big fan of this town! Just like the rest of us!

Even with all the heady festivities here locally, I got the opportunity to go to Washington DC last week to represent Annapolis at the US Conference of Mayors. Annapolis got a number of shout-outs for art, infrastructure, and other projects and initiatives.

On Friday, I was honored to attend a reception at the White House. I was greatly encouraged to hear the President talk about the valuable role of Mayors and that he wants his administration to work closely with us and local communities. I was also very fortunate and honored to meet other high-ranking officials such as Secretary of Commerce Gina Raimondo and Secretary Marcia Fudge of the Department of Housing and Urban Development, among many others.

The conference is a great opportunity to raise the profile of Annapolis, to share what we are doing with other mayors and federal leaders, and get insight and ideas - from both Democrats and Republicans. It represents the spirit-building, creative thinking, and partnership we need right now to get things done and heal our country.

We have great news about the forward momentum on the rebuild of Hillman Garage. On or around Friday, Feb. 3, the construction crew and those involved with this project will celebrate the "topping out" of the garage. Finally tonight I want to let you know about the Listening Session for Robinwood residents being held this Thursday January 26th through the NAM initiative out of the Mayor's office. This session is part of our No Harm Violence Prevention Program and will take place in the Robinwood Community Center, 1469 Tyler Ave, from 5:30 to 7:30pm. The session is free and open to the public.

Gun violence prevention remains a high priority for my administration. In 2022, we saw some improvements, but we still had incidents of shots fired, a few gun violence injuries and one death. That is one death too many.

We know that the scourge of gun violence remains with us. Just last night we had our first

homicide. Annapolis Police detectives are investigating this incident, but the pain of losing a young resident in a shooting incident, and the terror created by a shooting in an Annapolis neighborhood reminds us that our work must continued. I want to extend my deepest sympathies to the family and friends and to the community.

I also want the community to know that our Annapolis Police will not gie up and will hold the perpetrators to account.

Mayor Buckley moved to amend O-33-22 as follows:

#### AMENDMENT 1 – Mayor Buckley

(on Behalf of the Annapolis Ethics Commission)

**PURPOSE OF AMENDMENT:** To conform to the State Ethics Commission general counsel office's suggested changes.

**\$20 limits were increased to \$25 in the bill, and are changed back to \$20**

**On page 7 in line 30, strike "\$25" and insert "\$20".**

**(3)iii.Unsolicited gifts of nominal value that do not exceed twenty dollars \$25 \$20 in cost or trivial items of informational value;**

**On page 12, in line 26, strike "\$25" and insert "\$20".**

**a. A statement filed under this section shall include a schedule of each gift in excess of twenty dollars \$25 \$20 in value or a series of gifts totaling one hundred dollars \$100 or more received during the reporting period from or on behalf of, directly or indirectly, any person who does business with the City OR FROM AN ASSOCIATION, OR ANY ENTITY ACTING ON BEHALF OF AN ASSOCIATION THAT IS ENGAGED ONLY IN REPRESENTING COUNTIES OR MUNICIPAL CORPORATIONS.**

**On page 16, in line 32, strike "\$25" and insert "\$20".**

#### **3. Gifts.**

**a. A statement filed under this section shall include a schedule of each gift in excess of twenty dollars\$25 \$20 in value or a series of gifts totaling one hundred dollars\$100 or more received during the reporting period from or on behalf of, 34 directly or indirectly, any one person who does business with the City.**

**Moving (d) to end of section, and making it a separate subsection.**

**On page 12, strike lines 1-4, " d. AN INDIVIDUAL WHO IS REQUIRED TO DISCLOSE THE NAME OF A BUSINESS UNDER THIS SECTION SHALL DISCLOSE ANY OTHER NAMES THAT THE BUSINESS IS TRADING AS OR DOING BUSINESS AS."**

On page 14, after subsection "10." insert subsection "11." and insert the following " AN INDIVIDUAL WHO IS REQUIRED TO DISCLOSE THE NAME OF A BUSINESS UNDER THIS SECTION SHALL DISCLOSE ANY OTHER NAMES THAT THE BUSINESS IS TRADING AS OR DOING BUSINESS AS.

d. AN INDIVIDUAL WHO IS REQUIRED TO DISCLOSE THE NAME OF A BUSINESS UNDER THIS SECTION SHALL DISCLOSE ANY OTHER NAMES THAT THE BUSINESS IS TRADING AS OR DOING BUSINESS AS.

11. AN INDIVIDUAL WHO IS REQUIRED TO DISCLOSE THE NAME OF A BUSINESS UNDER THIS SECTION SHALL DISCLOSE ANY OTHER NAMES THAT THE BUSINESS IS TRADING AS OR DOING BUSINESS AS.

Removing reporting requirements from "Employees and Appointed Officials" section.

On page 17, in line 2, strike "(1)i.", strike "; and", and strike lines 6-8.

4. Employment with or interests in entities doing business with the City.

a. (1)i. A statement filed under this section shall include a schedule of all offices, directorships, and salaried employment by the individual or member of the immediate family of the individual held at any time during the reporting period with entities doing business with the City; and.

(2)ii. For a statement filed on or after January 1, 2019, if the individual's spouse is a regulated lobbyist, shall include a schedule of all entities that engaged the spouse for lobbying purposes.

(after edit)

4. Employment with or interests in entities doing business with the City.

a. A statement filed under this section shall include a schedule of all offices, directorships, and salaried employment by the individual or member of the immediate family of the individual held at any time during the reporting period with entities doing business with the City.

Clarifying who is impacted by the requirement

On page 19, in lines 31 & 32, strike "parties to the complaint" and insert "respondent".

E. If there is a reasonable basis for believing a violation has occurred, then the parties to the complaint RESPONDENT shall be afforded an opportunity for a hearing before the commission. Seconded. CARRIED on voice vote.

Alderman Schandelmeier moved to adopt O-33-22 as amended on second reader. Seconded. CARRIED on voice vote.

Alderman Schandelmeier moved to adopt O-33-22 on third reader. Seconded. A roll call vote was taken. The motion CARRIED by the following vote:
