29 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**
30 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

32 **Title 11 - PUBLIC PEACE, MORALS AND WELFARE**

33 **Chapter 11.12 - Public Peace and Order**

34 **Section 11.12.095 - Street-end Park Hours**

36 **A. Tolson Street Park.** A person may not enter or be present on the City property known as
37 Tolson Street Park, either on foot or by means of any vehicle, at any time between 10
38 p.m. and 7 a.m. except for the purpose of attending or participating in an activity,
39 program or event sponsored by or conducted under the auspices of the Department of
40 Recreation and Parks.

41 **B. Tucker Street Park.** A person may not enter or be present on the City property known as
42 Tolson Street Park, either on foot or by means of any vehicle, at any time between 10
43 p.m. and 7 a.m. except for the purpose of attending or participating in an activity,
