22	WHEREAS: The Land Use Article, Division 1, of the Maryland Code requires local
23	jurisdictions to "enact, adopt, amend, and execute" a comprehensive plan; and

25 26	WHEREAS: The comprehensive plan shall be assembled by the planning commission and, per Title 3 of the Land Use Article, Division 1, include the following elements:

28	2. Areas of critical State concern;
29	3. Goals and objectives;
30	4. Housing;

33	7. Sensitive areas;
34	8. Transportation;

Busch Library, the Eastport Annapolis Neck Library, City Hall, and the Department of Planning and Zoning, and digital copies available through a dedicated website at www.annapolisahead2040.com; and
16 17 18 19	WHEREAS:	The Planning Commission conducted a series of public hearings on the draft Plan between June 15, 2023, and September 21, 2023, and throughout those hearings, considered the comments received, including the following groups:

23		4. Written comments from the Maryland Department of Planning; and
24 25 26 27 28	WHEREAS:	The Planning Commission has made and approved a comprehensive plan, per § 3 202 of the Land Use Article, entitled "Annapolis Ahead Comprehensive Plan 2040" and by a vote of 4-0 (one member absent) recommends the plan adoption; and
30 31 32	WHEREAS:	The Planning Commission considers the plan a necessary guide to the future development of the City of Annapolis; and
33 34 35	WHEREAS,	The Planning Commission transmitted the Annapolis Ahead Comprehensive Plan 2040 to the Annapolis City Council on February 12; and
36 37 38	WHEREAS,	The City Council held a public hearing on the Comprehensive Plan on, 2024; and

1 2	WHEREAS,	The City Council has determined that it is in the public interest that the new Plan recommended by the Planning Commission be adopted as the Comprehensive		
3		Plan of the City of Annapolis; and

5	WHEREAS,	The plan shall constitute a general plan setting goals and a guide for future		
6		development.

8	WHEREAS,	The adoption of the plan shall not be construed as approval of individual projects		
9		that may be recommended therein, and the Aldermen/Alderwomen shall reserve		
10		to themselves the right to consider, debate, oppose, or support specific actions that		
11 12		may come before them that are intended to implement specific elements of the		
13		plan.
