TO THE EXTENT THAT MEETING SUCH ANTICIPATED COSTS WOULD REQUIRE A WATER RATE INCREASE OF LESS THAN FIVE PRECENT (5.00%) SUCH RATE INCREASE WILL AUTOMATICALLY BE APPLIED IN THE FOLLOWING FISCAL YEAR WITHOUT COUNCIL ACTION. TO THE EXTENT THE ANTICIPATED COST WOULD REQUIRE AN INCREASE IN EXCESS OF FIVE PERCENT, THE COUNCIL SHALL BE REQUIRED TO ACT AFFIRMATIVELY PRIOR TO THE START OF EACH FISCAL YEAR TO ESTABLISH AND ADOPT SUCH A RATE INCREASE."

On page 4, in line 33, after the period, strike as follows: "<u>THE FEE SCHEDULE SHALL</u> <u>REFLECT AN ANNUAL 2% RATE INCREASE IN EFFECT FROM JULY 1, 2015 UNTIL JUNE 30, 2018 FOR STORMWATER FEES UNDER THIS SECTION.</u>"

Page 4, line 40, after the period add the following: "PRIOR TO JUNE 30 EACH YEAR THE CITY SHALL COMPLETE A COST OF SERVICE RATE STUDYAND REPORT THE RESULTS TO THE COUNCIL. TO EXTENT THAT MEETING SUCH ANTICIPATED COSTS WOULD REQUIRE A STORMWATER UTILITY RATE INCREASE OF LESS THAN FIVE PERCENT (5.00%) SUCH RATER INCREASE WILL AUTOMATICALLY BE APPLIED IN THE FOLLOWING FISCAL YEAR WITHOUT COUNCIL ACTION. TO THE EXTENT THE ANTICIPATED COSTS WOULD REQUIRE AN IN CREASE IN EXCESS OF FIVE PERCENT, THE COUNCIL SHALL BE REQUIRED TO ACT AFFIRMATIVELY PRIOR TO THE START OF EACH FISCAL YEAR TO ESTABLISH AND ADOPT SUCH A RATE INCREASE."
