O-13-16 Annual Operating Budget: Fiscal Year 2017 - For the purposes of adopting an operating budget for the City of Annapolis for Fiscal Year 2017; appropriating funds for expenditures for Fiscal Year 2017; defraying all expenses and liabilities of the City of Annapolis and levying same for the purposes specified; specifying certain duties of the Director of Finance; and specifying a rate of interest to be charged upon overdue property taxes.

Alderwoman Pindell Charles moved to amend O-13-16 as follows:

O-13-16 Pindell Charles Littmann Proposed Amendments 1 and 2: AMENDMENT #1 Create a new Job Class "9501", Job Description "AFRICAN-AMERICAN COMMUNITY SERVICES SPECIALIST". This shall be a part-time, 20 hours per week, contractual position. The employee shall report to the City Manager. The fiscal impact of funding this position will be \$20,000.

Rationale: In an effort to address the concerns and the needs in the African American community, we propose to create the position of "African-American Community Services Specialist". The quality of life issues in the City of Annapolis is what entices people to live here. Unfortunately, all residents do not have the same opportunities or needs. There is an urgent need to provide such a Coordinator, who can assist in providing and alleviating the concerns of the African-American community. The suggestion of such a

Liaison/Coordinator (among other recommendations) emanated from the Caucus of African American Leaders following their Town Hall in 2015. Equitably addressing the needs of at least 28% of our City's residents is crucial. The creation of this position is vital to this segment of our community. Filling this position will in fact provide real, tangible, and perceived benefits to all City residents, e.g., assisting in addressing public safety issues inside and in proximity to our public housing and low income communities, etc. AMENDMENT #2

Create a new Job Class "9502", Job Description "HISPANIC COMMUNITY SERVICES SPECIALIST". This shall be a part-time, 20 hours per week, contractual position. The employee shall report to the City Manager. The fiscal impact of funding this position will be \$20,000.

Rationale: Person would be responsible for assisting City departments in making available City services to Spanish-only speakers, including explaining and / or translating as necessary for effective communication and provision of services; for creating and implementing a Limited English Proficiency (LEP) plan for Spanish-only speakers, and reaching out to and engaging with the Spanish speaking community and agencies, companies, and non-profits that provide services to assist Spanish-speakers. Seconded. CARRIED on voice vote.

Alderman Budge moved to reconsider his amendment to Alderman Arnett's amendment to O-13-16 as follows: Finance Committee Proposed Amendments to O-13-16 Annual Operating Budget, Amendment #3

Increase the Community Grants to \$90,000 of which 40,000 would be used to fund the 2 liaisons positions. Seconded. CARRIED on voice vote.

Alderman Littmann requested that Alderman Budge's amendment be postponed until the other amendments to O-13-16 have been addressed.

Alderman Budge moved to postpone his amendment as follows: Amendment #3 Increase the Community Grants to \$90,000 of which 40,000 would be used to fund the 2 liaisons positions until the other amendments to O-13-16 have been addressed. Seconded. CARRIED on voice vote.

Alderman Budge moved to amend O-13-16 as follows: O-13-16 Budge Amendment, Amendment 1:

Amend the FY17 Operating Budget Community Grants (Pro Forma Line 986) by adding a \$2,200.00 grant to the Bloomsbury Square Residents Council for the purpose of residential parking passes for members.

Rationale:

Bloomsbury Square is a HACA housing property that lies within Special Residential Parking District No. 1. Parking is limited to two hours per day between the hours 8:00 a.m. and 12:00 a.m., seven days per week unless a vehicle parked displays the special residential parking permit.

Residents of Bloomsbury Square use personal vehicles to reach places of employment, shopping, schools, and recreation. They have expressed difficulty affording the fees for parking permits, which can be \$55 or higher.

R-25-15 was introduced last year to address this concern. It failed following the Office of Law's opinion that the fee waiver proposed in the resolution would be unconstitutional. Law suggested the concern might be addressed through a grant, instead.

This amendment proposes that grant. Finance tells us that presently 15 vehicles registered to residents of Bloomsbury Square have parking permits. The Residents Council estimates that 40 vehicles would participate in the program. 40 x \$55 = \$2,200, the amount of this grant. Seconded. CARRIED on voice vote.

Alderman Budge moved to amend O-13-16 as follows: With the elimination of the Deputy Harbor Masters Position to remove \$30,000 from the Harbor Masters Budget. Seconded. CARRIED on voice vote.

Chief Pristoop and Director of Neighborhoods and Environmental Programs Director Broadbent were present and answered questions from council.

Alderwoman Pindell Charles moved to amend O-13-16 as follows: O-13-16 Pindell Charles Proposed AMENDMENT #1

Create a new Job Class "9109", Job Description "ALCOHOLIC BEVERAGE CONTROL INSPECTOR". This shall be a contractual, part-time position under the Police Department. Seconded. CARRIED on voice vote.
