### RECOMMENDATION FOR ACTION

The Housing and Community Development Committee hereby submits to the City Council the following matter for the action indicated:

Allocation of FY 2018 Community Development Block Grant funding for Capital and Public Service Projects

The estimated amount available to fund the City's Community Development Block Grant projects for FY 2018 is \$249,088 in entitlement funds and \$18,000 in Program Income. Proposals for capital and community service projects were presented to the Housing and Community Development Committee at a public hearing on February 21, 2017. At the regular meeting of the Committee on March 21, 2017, the **Committee voted to recommend the allocation of funds as shown on the attached worksheet.**

**RECOMMENDATION: Approve the Housing and Community Development Committee's allocations of CDBG funds to capital and service projects as voted on March 21, 2017.**
