38	A. Exe	cept for areas designated by City signage as metered spaces, reserved parking, and
39	no parking zones, a residential parking permit authorizes a resident of that district,	
40	whose vehicle displays a valid residential parking permit for that district, or which is	
41	otherwise registered with the city and the authorized agent as a permit holder, to park	
42		RMITTED VEHICLES all day on the designated streets within that district. A

19 00	A permit expires and is void when the licensee no longer resides within the district,
20 21	as defined in this chapter. A licensee shall remove any permit sticker, tag or barcode from any vehicle registered to park within the district upon its expiration or upon moving
22	outside of the district AND SHALL NOTIFY THE CITY OR THE AUTHORIZED
23	AGENT. Permits shall be transferred from one vehicle to another during the permit year
24	solely in accordance with regulations governing such transfers.

26	SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE
27	ANNAPOLIS CITY COUNCIL that this Ordinance shall take effect on the first day of
28	the calendar month that begins at least 30 days after the date of its passage.
