27	WIIEKEAS,	17, 2011, authorized the Mayor to enter into vendor leases for the Market
28		House on behalf of the City for terms not to exceed five (5) years; and

30	WHEREAS,	the Mayor of Annapolis entered into six vendor leases for the Market
