3. Legislation before Committee

O-36-17

Wheel Immobilization Devices - Prohibited - For the purpose of prohibiting the use of wheel immobilization devices on vehicles parked on public or private property in the City of Annapolis.

Police Chief Baker was present and answered questions from the committee. City Manager Andrews was present and answered questions from the committee. Stated that there was a difference of opinion between the administration and the Transportation Board as to whether or not "booting" should be allowed on private property. Alderman Budge was present and addressed the committee. Stated that the Transportation Board recommended that the booting of vehicles is a matter between to private parties and that the City should not intervene. He also stated that the Committee should take into consideration the stance of the private parking lot operator in reference to how would he or she enforce their parking rules if this legislation is passed. The Transportation Board opposes the legislation.

Alderman Paone suggested private lots posts signs so that an individual will know what they are getting into by parking there.

Madam Chair motioned to postpone until the Transportation Committee amends the legislation.
