1 All appointed members of committees, commissions, boards and authorities shall 2 attend their respective meetings on a regular basis. For the purpose of this section, 3 "attendance" includes the participation of a member via pre-arranged telephone 4 conference. A member may attend a meeting via telephone conference no more than four 5 times within one calendar year. Attendance at a meeting via telephone conference shall 6 count toward the meeting quorum. Members of quasi-judicial committees, commissions, 7 boards and authorities are prohibited from attending meetings via telephone conference. 8 9 10 If any member who is entitled to vote is absent for three consecutive meetings or is absent for more than four meetings within one calendar year, the Chair shall notify the 11 Mayor and City Council in writing within ten days.
