18 **AN ORDINANCE** concerning

20 **Capital Budget Fiscal Year 2019**

21  
22 **FOR** the purpose of adopting a capital budget for Fiscal Year 2019; and appropriating funds  
23 for expenditures for the Fiscal Year 2019 capital budget.

25 **WHEREAS,** pursuant to Section 6.16.030 of the Annapolis City Code, on April 9, 2018, the  
26 Mayor submitted to the City Council a capital budget for the ensuing fiscal year  
27 and a capital improvement program for the ensuing five fiscal years; and

29 **WHEREAS,** O-17-18 was referred to the Planning Commission, which held a meeting after  
30 proper public notice, to receive evidence and testimony as it judged to be  
31 relevant to the consideration of the capital budget and capital improvement  
32 program; and

34 **WHEREAS,** on \_\_\_\_\_, the Annapolis City Council held a public hearing on  
35 the capital budget for the City of Annapolis for Fiscal Year 2019; and

37 **WHEREAS,** the attached capital improvement budget for Fiscal Year 2019 is submitted to  
38 the Annapolis City Council for its consideration and approval.

40 **NOW, THEREFORE:**

42 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
43 **COUNCIL** that pursuant to Section 6.16.030 of the Annapolis City Code, the capital budget for  
44 Fiscal Year 2019, attached to this ordinance and made a part hereof, be and the same is hereby  
45 adopted and approved.

2 **SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
3 **ANNAPOLIS CITY COUNCIL** that funds for all expenditures for the purposes specified in the  
4 capital budget for Fiscal Year 2019 are hereby appropriated in the amounts therein specified and  
5 will be used by the City in the sums itemized in said budget hereby adopted for the principal  
6 objectives and purposes thereof, and the total sum of funds herein provided for the respective  
7 departments and major operating units thereof, boards, commissions and agencies.

9 **SECTION III: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE**  
10 **ANNAPOLIS CITY COUNCIL** that this Ordinance shall take effect on July 1, 2018.
