TITLE 1 – GENERAL PROVISIONS

Chapter 1.08 – CITY EMBLEMS

•

Section 1.08.060 — City Emblems - Prohibited Uses.

For the purposes of this Section only, "City Emblem" <u>includes</u> is defined as the city seal, <u>eity flag</u> and city logo.

- A. It shall be unlawful for an individual or entity to make or use any city emblem, or any representation or near representation thereof, for any purpose other than for the official business of the City of Annapolis and by any individual or entity other than the city council, a department, official or employee of the city, unless expressly approved in writing by the city manager or designee in advance of any such use.
- B. <u>A. The City emblems, or any representation or near representation thereof, shall not be used for:</u>
 - 1. any political purpose, including but not limited to, campaign literature, mailers or handouts; or
 - 2. any purpose which in a manner that would lead a reasonable person to mistakenly mislead the public into believeing that such the City of Annapolis, the city council, or any department, official, or employee of the city representation implies the endorsesment, supports, approvesal, or sponsorship, the stated political purpose participation, involvement, or association with by the City of Annapolis, the city council, or any department, official, or employee of the city.
- C. <u>B.</u> A violation of section 1.08.060(aA) or (b) is a municipal infraction and the individual or entity shall be subject to a fine as established by resolution of the city council.

SECTION II: AND BE IT FURTHER ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY COUNCIL that this Ordinance shall take effect from the date of its passage.
