19 **Dedication of City Property**

21 **FOR** the purpose of dedicating the City Hall Gallery to former Mayor Ellen O. Moyer and
22 installing a plaque in the Gallery to commemorate said dedication.

24 **WHEREAS,** Former Mayor Ellen Moyer has been a champion of the arts in the City of
25 Annapolis since the 1960s, her hand and vision can be found in Maryland Hall
26 (founding member), Annapolis Summer Garden Theater, Annapolis Maritime
27 Museum and the AIPPC and the West Street Arts District

28
29 **WHEREAS,** the City Hall Gallery was established under former Mayor Ellen Moyer's
30 administration and at her direction; and

32 **WHEREAS,** former Mayor Ellen Moyer's impressive biography includes: Executive Director,
33 Maryland Commission for Women in the late 1970s, Lobbyist for the Maryland
34 State Teachers Association, Member, Strategic Committee on the State Plan for
35 Higher Education from 1999 to 2000, Member, Maryland Racing Commission
36 from 1999 to 2003, Alderwoman, Annapolis City Council from 1987 to 2001,
37 first woman Mayor of Annapolis, from 2001 to 2009; and

39 **WHEREAS,** during her tenure as Mayor, former Mayor Ellen Moyer established the Annapolis
40 Conservancy Board and the City's Greenscape program, which for those of us
41 who find art in nature, means that she was incremental in establishing the street
42 end parks in Eastport (and around Annapolis), and the extensive tree canopy in
43 Annapolis, which exists largely because of her persistence and leadership; and

45 **NOW, THEREFORE,**

1 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City Hall Gallery is
2 hereby dedicated to former Mayor Ellen O. Moyer.

4 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that a
5 plaque shall be erected in the City Hall Gallery to commemorate said dedication.

7 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that this
8 resolution shall take effect from the date of its passage.
