Statement of Interest in the Planning Commission - Alex Pline

In my more than twenty years as a resident, I have come to see Annapolis as a diverse, vibrant, small city in and of itself, not just a bedroom community of Washington or Baltimore. It offers a wonderful quality of life to residents with its compact mix of urban/commercial areas and walkable neighborhoods. These are the strengths of the City and are primary goals outlined in the Comprehensive Plan. As a member of the Planning Commission, I would work to further those goals.

While I have no formal training in city planning, I am an informal student of "new urbanism" — an urban planning/design movement which promotes a traditional pattern of human scaled, walkable urban areas and neighborhoods. In fact I am planning on pursuing a planning degree upon my retirement from NASA. The specific area I am interested in is the nexus of land use and transportation, which I see is a major issue as further development occurs in the City. These are flip sides of the same coin; choices in one affect the other — and vice versa — often in counterintuitive ways.

I am very interested in seeing development in Annapolis that allows the City to grow in a fiscally and environmentally sustainable way while at the same time maintaining its historic nature. I believe development that is good for the City requires a holistic view taking into account land use, transportation, lifecycle costs for supporting City infrastructure and historic preservation where appropriate. My engineering background, experience with local transportation issues and keen interest in city planning allows me to bring this holistic view to the Planning Commission.
