TITLE 2 – ADMINISTRATION

Chapter 2.08 – PUBLIC ETHICS AND FINANCIAL DISCLOSURE

Section 2.08.020 - Definitions.

1
2 A. Definitions. The following words and phrases shall have the meanings ascribed to
3 them as follows:

- 4
- 5 1. "Business entity" means a corporation, limited liability company, general or
6 limited partnership, sole proprietorship, joint venture, unincorporated
7 association or firm, institution, trust, foundation, or other organization, whether
8 or not operated for profit. "Business entity" does not include a governmental
9 entity.
 - 10 2. "Commission" means the City of Annapolis Ethics Commission as established
11 in Section 2.08.030.
 - 12 3. "Compensation" means any money or thing of value, regardless of form,
13 received or to be received by any individual covered by this chapter from an
14 employer for service rendered. For the purposes of Section 2.08.070 of this
15 chapter, if lobbying is only a portion of a person's employment, "compensation"
16 means a prorated amount based on the time devoted to lobbying compared to the
17 time devoted to other employment duties.
 - 18 4. "Doing business with" means:
 - 19 a. Having or negotiating a contract that involves the commitment (either in a
20 single or combination of transactions) of one thousand dollars or more of
21 City controlled funds; or
 - 22 b. Being regulated by or otherwise under the authority of the City; or
 - 23 c. Being registered as a lobbyist in accordance with Section 2.08.070 of this
24 chapter.
 - 25 5. "Elected official" includes the Mayor and members of the City Council.
 - 26 6. "Employee" means an individual who is employed by the City of Annapolis.
27 "Employee" does not include an elected official.
 - 28 7. "Financial interest" means:
 - 29 a. Ownership of any interest as the result of which the owner has received,
30 within the past three years, or is presently receiving, or in the future is
31 entitled to receive, more than one thousand dollars per year in
32 compensation; or
 - 33 b. Ownership, or the ownership of securities of any kind representing or
34 convertible into ownership, of more than three percent of a business entity
35 by a City official or employee, or the spouse of an official or employee.
 - 36 8. "Gift" means the transfer of anything of economic value regardless of the form
37 without adequate and lawful consideration, whether or not it relates to the
38 performance of official duties. However, "gift" does not include the solicitation,
39 acceptance or receipt of any campaign contributions regulated in accordance
40 with any law pertaining to the conduct of elections or the receipt of political
41 campaign contributions.
 - 42 9. "Interest" means any legal or equitable economic interest, whether or not subject
43 to an encumbrance or a condition, which was owned or held, in whole or in part,
44 jointly or severally, directly or indirectly. For purposes of Section 2.08.050 of
45 this chapter, "interest" applies to any interests held at any time during the

1 calendar year for which a required statement is to be filed. "Interest" does not
2 include:

- 3 a. An interest held in the capacity of a personal agent, representative
4 custodian, fiduciary, or trustee, unless the holder has an equitable interest
5 therein;
- 6 b. An interest in a time or demand deposit in a financial institution;
- 7 c. An interest in an insurance or endowment policy or annuity contract under
8 which an insurance company promises to pay a fixed number of dollars
9 either in a lump sum or periodically for life or some other specified period;
- 10 d. A common trust fund or a trust which forms part of a pension or profit
11 sharing plan which has more than twenty-five participants and which has
12 been determined by the Internal Revenue Service to be a qualified trust
13 under §§ 401 and 501 of the Internal Revenue Code of 1954;
- 14 e. An interest in a City pension plan, City deferred compensation plan or a
15 college savings plan under the Internal Revenue Code; or
- 16 f. An interest in any mutual fund or exchange-traded fund that is publicly
17 traded on a national scale unless the mutual fund or exchange-traded fund is
18 composed primarily of holdings of stock and interests in a specific sector or
19 area that is regulated by the City of Annapolis.

20 10. "Lobbyist" or "lobbying" means the person or act of communicating in the
21 presence of a City official or employee with the intent to influence any official
22 action of that official or employee; or the person or act of engaging in activities
23 having the express purpose of soliciting others to communicate with a City
24 official or employee with the intent to influence that official or employee; and
25 who expends (exclusive of personal travel and subsistence) in excess of two
26 hundred fifty dollars per calendar year on food, entertainment or gifts for any
27 official or employee of the City.

28 11. "Official" means an elected official, an employee of the City directly or by
29 contract, or a person appointed to or employed by a City agency, board,
30 commission, or similar entity whether or not paid in whole or in part with City
31 funds and whether or not compensated. Members of the Board of
32 Commissioners of the Housing Authority of the City of Annapolis (HACA), the
33 Executive Director of HACA and the Deputy Director(s) of HACA are part of a
34 separate entity; however, in accordance with State law, and for purposes of the
35 City Ethics law, the individuals in these HACA positions are considered City
36 officials.

37 12. "Person" includes any natural person, or business entity.

38 13. "Qualified relative" means spouse, siblings, parents, children, and their spouses.

39 14. "Immediate family" means a spouse and dependent children, and anyone else
40 living in an official's residence.

41
42 **Section 2.08.050 - Financial disclosure for elected officials and candidates for elected**
43 **office.**

44
45 A. This section applies to all elected officials and candidates for elected office:
46

1 B. Except as provided in subsection D. of this section, an elected official or a candidate
2 to be an elected official shall file the financial disclosure statement required under
3 this subsection:

- 4
- 5 1. On a form provided by the Commission;
- 6 2. Under oath or affirmation; and
- 7 3. With the Commission.
- 8

9 C. Deadlines for filing statements.

- 10
- 11 1. An incumbent official shall file a financial disclosure statement annually no later
12 than January 31 of each year for the preceding calendar year.
- 13 2. An official who is appointed to fill a vacancy in an office for which a financial
14 disclosure statement is required and who has not already filed a financial
15 disclosure statement shall file a statement for the preceding calendar year within
16 thirty days after appointment.
- 17 3. Officials leaving office.
 - 18
 - 19 a. An individual who, other than by reason of death, leaves an office for which
20 a statement is required shall file a statement within sixty days after leaving
21 the office.
 - 22 b. The statement shall cover:
 - 23
 - 24 (1) The calendar year immediately preceding the year in which the
25 individual left office, unless a statement covering that year has already
26 been filed by the individual; and
 - 27 (2) The portion of the current calendar year during which the individual
28 held the office.
 - 29

30 D. Candidates to be elected officials.

- 31
- 32 1. Except for an official who has filed a financial disclosure statement under
33 another provision of this section for the reporting period, a candidate to be an
34 elected official shall file a financial disclosure statement each year beginning
35 with the year in which the certificate of candidacy is filed through the year of
36 the election.
- 37
- 38 2. A candidate to be an elected official shall file a statement required under this
39 section:
 - 40
 - 41 a. In the year the certificate of candidacy is filed, no later than the filing of the
42 certificate of candidacy;
 - 43 b. In the year of the election, on or before the earlier of April 30 or the last day
44 for the withdrawal of candidacy; and
 - 45 c. In all other years for which a statement is required, on or before April 30.
 - 46
- 47 3. A candidate to be an elected official:

- a. May file the statement required under subsection D.2.a. of this section with the City Clerk or Board of Election supervisors with the certificate of candidacy or with the Commission prior to filing the certificate of candidacy; and
- b. Shall file the statements required under subsection D.2.b. and D.2.c. of this section with the Commission.

4. If a candidate fails to file a statement required by this section after written notice is provided by the City Clerk or Board of Election Supervisors at least twenty days before the last day for the withdrawal of candidacy, the candidate is deemed to have withdrawn the candidacy.
5. The City Clerk or Board of Election Supervisors may not accept any certificate of candidacy unless a statement required under this section has been filed in proper form.
6. Within thirty days of the receipt of a statement required under this section, the City Clerk or Board of Election Supervisors shall forward the statement to the Commission.

E. Public record.

1. The City Attorney's office shall maintain all financial disclosure statements filed under this section.
2. The City Attorney's office shall make financial disclosure statements available during normal office hours for examination by the public.
3. If an individual examines a financial disclosure statement, the City Attorney's office shall:
 - a. Redact any portion of a statement, filed after January 1, 2019, that includes the home address of the person whose financial disclosure statement was examined;
 - b. Record the name, ~~employer, and home and office~~ and addresses of the individual reviewing the statement;
 - c. Record the name of the person whose financial disclosure statement was examined; and
 - d. Notify the person whose financial disclosure statement was examined of the information recorded in paragraph 3.b. above.

F. Retention requirements. The City Attorney's office shall retain financial disclosure statements for four years from the date of receipt.

G. Contents of statement.

1. Interests in real property.
 - a. A statement filed under this section shall include a schedule of all interests in real property wherever located.
 - b. For each interest in real property, the schedule shall include:

- 1 (1) The nature of the property and the location by street address, mailing address,
2 or legal description of the property;
- 3 (2) The nature and extent of the interest held, including any conditions and
4 encumbrances on the interest;
- 5 (3) The date when, the manner in which, and the identity of the person from
6 whom the interest was acquired;
- 7 (4) The nature and amount of the consideration given in exchange for the interest
8 or, if acquired other than by purchase, the fair market value of the interest at
9 the time acquired;
- 10 (5) If any interest was transferred, in whole or in part, at any time during the
11 reporting period, a description of the interest transferred, the nature and
12 amount of the consideration received for the interest, and the identity of the
13 person to whom the interest was transferred; and
- 14 (6) The identity of any other person with an interest in the property.
- 15
- 16 2. Interests in corporations and partnerships.
- 17
- 18 a. A statement filed under this section shall include a schedule of all interests
19 in any corporation, partnership, limited liability partnership, or limited
20 liability corporation, regardless of whether the corporation or partnership
21 does business with the City.
- 22 b. For each interest reported under this paragraph, the schedule shall include:
23
- 24 (1) The name and address of the principal office of the corporation, partnership,
25 limited liability partnership, or limited liability corporation;
- 26 (2) The nature and amount of the interest held, including any conditions and
27 encumbrances on the interest;
- 28 (3) With respect to any interest transferred, in whole or in part, at any time during
29 the reporting period, a description of the interest transferred, the nature and
30 amount of the consideration received for the interest, and, if known, the
31 identity of the person to whom the interest was transferred; and
- 32 (4) With respect to any interest acquired during the reporting period:
33
- 34 (I) The date when, the manner in which, and the identity of the person from
35 whom the interest was acquired; and
- 36 (II) The nature and the amount of the consideration given in exchange for
37 the interest or, if acquired other than by purchase, the fair market value
38 of the interest at the time acquired.

- 40 c. An individual may satisfy the requirement to report the amount of the
41 interest held under item b.(2) of this paragraph by reporting, instead of a
42 dollar amount:
43
- 44 (1) For an equity interest in a corporation, the number of shares held and, unless
45 the corporation's stock is publicly traded, the percentage of equity interest
46 held; or
- 47 (2) For an equity interest in a partnership, the percentage of equity interest held.

2 3. Interests in business entities doing business with City.

4 a. A statement filed under this section shall include a schedule of all interests
5 in any business entity that does business with the City, other than interests
6 reported under paragraph 2. of this subsection.

7 b. For each interest reported under this paragraph, the schedule shall include:

- 8
9 (1) The name and address of the principal office of the business entity;
10 (2) The nature and amount of the interest held, including any conditions to and
11 encumbrances on the interest;
12 (3) With respect to any interest transferred, in whole or in part, at any time during
13 the reporting period, a description of the interest transferred, the nature and
14 amount of the consideration received in exchange for the interest, and, if
15 known, the identity of the person to whom the interest was transferred; and
16 (4) With respect to any interest acquired during the reporting period:

18 (I) The date when, the manner in which, and the identity of the person from
19 whom the interest was acquired; and

20 (II) The nature and the amount of the consideration given in exchange for
21 the interest or, if acquired other than by purchase, the fair market value
22 of the interest at the time acquired.

26 a. A statement filed under this section shall include a schedule of each gift in
27 excess of twenty dollars in value or a series of gifts totaling one hundred
28 dollars or more received during the reporting period from or on behalf of,
29 directly or indirectly, any one person who does business with the City.

30 b. For each gift reported, the schedule shall include:

- 31
32 (1) A description of the nature and value of the gift; and
33 (2) The identity of the person from whom, or on behalf of whom, directly or
34 indirectly, the gift was received.

35
36 5. Employment with or interests in entities doing business with City.

37
38 a. A statement filed under this section shall include a schedule of all offices,
39 directorships, and salaried employment by the individual or member of the
40 immediate family of the individual held at any time during the reporting
41 period with entities doing business with the City.

42 b. For each position reported under this paragraph, the schedule shall include:

- 43
44 (1) The name and address of the principal office of the business entity;
45 (2) The title and nature of the office, directorship, or salaried employment held
46 and the date it commenced; and

- 1 (3) The name of each City agency with which the entity is involved as indicated
2 by identifying one or more of the three categories of "doing business", as
3 defined in Section 2.08.020 A.4. of this chapter.
4
- 5 6. Indebtedness to entities doing business with City.
6
- 7 a. A statement filed under this section shall include a schedule of all liabilities,
8 excluding retail credit accounts, to persons doing business with the City
9 owed at any time during the reporting period:
10
- 11 (1) By the individual; or
12 (2) By a member of the immediate family of the individual if the individual was
13 involved in the transaction giving rise to the liability.
14
- 15 b. For each liability reported under this paragraph, the schedule shall include:
16
- 17 (1) The identity of the person to whom the liability was owed and the date the
18 liability was incurred;
19 (2) The amount of the liability owed as of the end of the reporting period;
20 (3) The terms of payment of the liability and the extent to which the principal
21 amount of the liability was increased or reduced during the year; and
22 (4) The security given, if any, for the liability.
23
- 24 7. Employment with City. A statement filed under this section shall include a
25 schedule of the immediate family members of the elected official or candidate
26 for elected office in any capacity at any time during the reporting period.
27
- 28 8. Sources of earned income.
29
- 30 a. A statement filed under this section shall include a schedule of the name
31 and address of each place of employment and of each business entity of
32 which the individual or a member of the individual's immediate family was
33 a sole or partial owner and from which the individual or member of the
34 individual's immediate family received earned income, at any time during
35 the reporting period.
36
- 37 b. A minor child's employment or business ownership need not be disclosed if
38 the agency that employs the individual does not regulate, exercise authority
39 over, or contract with the place of employment or business entity of the
40 minor child.
- 41 9. A statement filed under this section may also include a schedule of additional
42 interests or information that the individual making the statement wishes to
43 disclose.
- 44 H. For the purposes Section 2.08.050 G.1., 2., and 3. of this chapter, the following
45 interests are considered to be the interests of the individual making the statement:
46

- 1 1. An interest held by a member of the individual's immediate family, if the interest
2 was, at any time during the reporting period, directly or indirectly controlled by
3 the individual.
- 4 2. An interest held by a business entity in which the individual held a thirty percent
5 or greater interest at any time during the reporting period.
- 6 3. An interest held by a trust or an estate in which, at any time during the reporting
7 period:

9 a. The individual held a reversionary interest or was a beneficiary; or
10 b. If a revocable trust, the individual was a settlor.

- 12 I. The Commission shall review the financial disclosure statements submitted under
13 this section for compliance with the provisions of this section and shall notify an
14 individual submitting the statement of any omissions or deficiencies.

- 20 A. This section applies to the following employees and appointed officials:

22 1. The City Manager, City Attorney, all department directors and deputies, and all
23 members of the exempt service, and
24 2. Members of the Board of Commissioners of the Housing Authority of the City
25 of Annapolis (HACA), the Executive Director of HACA and the Deputy
26 Director(s) of HACA, and
27 3. Inspectors and investigators who enforce City Codes, City Procurement Officers
28 and their purchasing staff, and members of the following quasi-judicial boards
29 and commissions: the Board of Appeals, the Civil Service Board, the Building
30 Board of Appeals, the Historic Preservation Commission, the Planning
31 Commission, the Board of Supervisors of Elections, the Ethics Commission,
32 Port Wardens, and the Police and Fire Retirement Plan Commission, and
33 ~~34.~~ All other City officials, employees, contract employees or temporary employees
34 over pay grade 15, F15 (Fire Department), and P15 (Police Department), or who
35 have authority to award or recommend the award of contracts or grants, or who
36 provide advice or counsel to the City on matters pertaining to public policy or
37 acquisition, ~~and~~
38 ~~45.~~ Members and employees of the quasi-judicial Alcoholic Beverage Control
39 Board are exempt from this section but shall file financial disclosure statements
40 with the State Ethics Commission in accordance with Maryland Public Ethics

1 paragraph A. that have not already filed a financial disclosure statement, such
2 employees and appointed officials shall file a financial disclosure statement no later
3 than fifteen days after commencing employment or service pursuant to their
4 appointment or within fifteen days of the enactment of this ordinance.
