16 **A RESOLUTION** concerning

18 **City Sponsored Special Event – Elks Annual Pre-Labor Day Parade**

19  
20 **FOR** the purpose of identifying the “Elks Annual Pre-Labor Day Parade” held on  
21 September 2, 2018, as a City Sponsored Special Event; and waiving certain  
22 related City fees for that event.

23  
24 **WHEREAS,** on September 2, 2018 the Ancient City Elks Lodge #175 sponsored the  
25 Elks Annual Pre-Labor Day Parade Special Event from Amos Garrett  
26 Blvd en route along West Street to Calvert Street in Annapolis, Maryland;  
27 and

29 **WHEREAS,** Section 14.18.020 of the City Code defines “City Sponsored Events” as  
30 “special events for which the City waives some or all fees or otherwise  
31 directly participates in the cost of the event”; and

32  
33 **WHEREAS,** Section 14.18.110 of the City Code further states that “the City Council  
34 may exempt certain special events from fees by resolution”; and

35  
36 **WHEREAS,** in 2019 and prior fiscal years the City has waived certain City fees for the  
37 Martin Luther King, Jr. Parade, the Memorial Day Parade, the  
38 Independence Day Parade, the USNA Band Concerts, the Kunta Kinte  
39 Festival, the Tug of War, the Grand Illumination, the Lights Parade, and  
40 the New Year’s Eve Celebration.

42 **NOW THEREFORE,**

43  
44 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the September 2,  
45 2018 Elks Annual Pre-Labor Day Parade is designated a City Sponsored Special Event

1 during Fiscal Year 2019 in recognition of its significance to our heritage and public  
2 service to our City.

4 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that  
5 there shall be a waiver of full fees for the September 2, 2018 Elks Annual Pre-Labor Day  
6 Parade, a City Sponsored Special Event.

8 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that  
9 this resolution shall take effect from the date of its passage.
