14 **A RESOLUTION** concerning

16 **2019 St. Patrick’s Day Parade –Waiver of Fees**

17  
18 **FOR** the purpose of identifying the St. Patrick’s Day Parade Special Event that will be  
19 held on March 10, 2019; and waiving certain related City fees for that event.

20  
21 **WHEREAS,** on March 10, 2019, Naptown Events will sponsor the 7<sup>th</sup> Annual St.  
22 Patrick’s Day Parade Special Event in the Historic District of the City of  
23 Annapolis, Maryland; and

24  
25 **WHEREAS,** the 2019 St. Patrick’s Day Parade Special Event is expected to welcome  
26 over 10,000 participants and attendees from different parts of the world and  
27 nationwide, bringing much needed commercial stimulus to the businesses  
28 located within the City as well as tremendous enjoyment to its constituents  
29 and visitors; and

31 **WHEREAS,** the 2019 St. Patrick’s Day Parade Special Event benefits local charities; and

33 **WHEREAS,** Section 14.18.110 of the City Code states that “the City Council may  
34 exempt certain special events from fees by resolution”; and

36 **WHEREAS,** in 2019 and prior fiscal years the City has waived certain City fees for the  
37 Martin Luther King, Jr. Parade, the Memorial Day Parade, the  
38 Independence Day Parade, the USNA Band Concerts, the Kunta Kinte  
39 Festival, the Tug of War, the Grand Illumination, the Lights Parade, the  
40 New Year’s Eve Celebration, and the Elks pre-Labor Day Parade.

43 **NOW THEREFORE,**

1 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the 2019 St.  
2 Patrick's Day Parade is hereby designated a Major Special Event in recognition of its  
3 significance to our heritage and public service to our City.

5 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that  
6 there shall be a waiver of full fees for the 2019 St. Patrick's Day Parade Major Special  
7 Event.

9 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that  
10 this resolution shall take effect from the date of its passage.
