32 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS**
33 **CITY COUNCIL** that the Code of the City of Annapolis shall be amended to read as
34 follows:

37 **Chapter 2.12 – MAYOR**

39 **Section 2.12.040 - ~~City Attorney~~OFFICE OF LAW.**

41 **A.** THE OFFICE OF LAW SHALL BE SUPERVISED BY THE CITY ATTORNEY,
42 WHO SHALL REPORT DIRECTLY TO THE MAYOR.

44 **B.** The City Attorney shall be appointed by the Mayor and confirmed by the CITY
45 eCouncil and shall meet the qualifications set forth in the Charter.

1 ~~BC.~~ The City Attorney'S shall have the following powers and duties IN THE
2 SUPERVISION OF THE OFFICE OF LAW INCLUDE THE POWER OR DUTY
3 TO:

- 5 1. ~~To~~ perform legal services for the City;
- 6 2. ~~To~~ perform advisory, documentary, and drafting services for the City;
- 7 3. ~~To~~ issue opinions upon questions affecting the interestS of the City;
- 8 4. ~~To~~ review and approve as to form and legal sufficiency each instrument to be
9 executed BY OR on behalf of the City;
- 10 5. ~~To~~ prepare and approve the title papers whenever the City purchases any real
11 estate and no contract shall be made or money paid on account of the purchase of
12 real property until the City Attorney certifies to the title of the property and legal
13 sufficiency of the deeds or other instruments intended to convey the property to
14 the City;
- 15 6. ~~To~~ assist the Mayor, Aldermen, AND ALDERWOMEN and ~~City Clerk~~ in the
16 preparation of legislation, AND
- 17 7. SUPERVISE THE DUTIES OF THE CITY CLERK.

- 21 A. The ~~Mayor~~ CITY ATTORNEY shall appoint a person to serve as City Clerk and a
22 person to serve as deputy City Clerk. The City Clerk and deputy City Clerk shall take
23 the oath prescribed by Article IX, Section 1 of the Charter.
- 24 B. The City Clerk shall certify and attest to the actions of the City and its officials.
- 25 C. The City Clerk shall keep permanent records of the proceedings of the City Council
26 as well as of all the laws, ordinances, resolutions, and orders of the City Council.
- 27 ~~D. The City Clerk shall advertise all elections which are to be held under the Charter, and
28 make A return of the same in the manner now provided for by the laws regulating
29 elections.~~
- 30 ~~E. The City Clerk shall prepare legislation at the request of the Mayor or any of the
31 Aldermen, for consideration by the City Council.~~
- 32 ~~FD.~~ The City Clerk shall be the custodian of the seal and of the permanent records and
33 instruments of the City.
- 34 ~~GE.~~ The Deputy City Clerk shall have the same powers and obligations and shall perform
35 the duties performed by the City Clerk, in the absence of the clerk, as authorized by
36 law.
