I want to remind the Council and invite the public to tune in to tomorrow's Work Session of the Annapolis City Council. It will be broadcast on City of Annapolis TV and live-streamed on Facebook and YouTube. That is tomorrow at three.

This work session will be especially for the City Dock Action Committee's final report on the consensus plan.

To remind everyone and introduce this to those unfamiliar with the committee, back in the spring of 2019, after the Urban Land Institute's TAP study, we put together a group of nearly 100 City residents and business stakeholders to make a determination for the future of City Dock.

This effort would not have been possible without the partnership of Historic Annapolis, thank you to Robert Clark and Bill Kardash, Preservation Maryland, and the National Trust for Historic Preservation.

We had grant funding for some elements of this effort, but we mostly had people give generously of their time and energy.

The City Dock Action Committee had a charge, not just to enhance quality of life issues for businesses and residents, but also because we have kicked the can

down the road on an issue that we can no longer afford to defer: flooding.

We know that flooding in downtown is both more intense and more frequent. We know that we have had other groups that have come before. We know that previous proposals have not been followed through on.

We have delayed action for so long that we no longer have the luxury of time.

Stanford University looked at the business impacts of flooding in a report that focused exclusively on Annapolis in the Spring of 2019. That study showed the costs the city and businesses face each time we delay in acting on a long-term solution to the resilience issues that confront downtown. It costs millions.

NOAA did a study last July that showed that Annapolis is ground zero for sea-level rise.

We can't afford NOT to act on behalf of our City, our residents, our businesses and future generations.

These 92 generous souls gave of their time and energy and passion to the nine workgroups. They interviewed 100s of businesses. They met with resident groups and held public hearings. They asked the hard questions and made compromises in order to find consensus.

They are going to present their consensus plan tomorrow. It's not really a secret, but if you've heard other reports, they might be rumors. Tune in tomorrow to hear the real deal. That's 3 pm Tuesday, right here in Council chambers, on City of Annapolis TV or live streaming on Facebook and YouTube.

One final note: I want to take this opportunity to thank each and every person who volunteered their time to serve on this committee. Thank you!

Speaking of education, I just wanted to let you all know that over the holidays we hosted, in our home, the presidents of St. Johns College, Anne Arundel Community College and the US Naval Academy. Jules and I, along with the presidents and their mates, had an opportunity to strengthen our personal and professional relationships by breaking bread together. We want to make sure that these post-secondary schools are more than just neighbors. We want them to be partners in the academic success of our residents. We want to look for ways to ensure that all of our residents have access to all of the educational opportunities in our community. #### Amendment #16

If approved, this amendment will supersede Amendment #2 of the Savidge, Tierney and Arnett Amendments that were moved and approved on 12/9/19)

On page 11, after line 9, insert:

"G. Steep Slopes and their buffers. Development is not permitted on slopes greater than or equal to twenty-five percent, including a twenty-five foot buffer on sites larger than or equal to 40,000 square feet and a five-foot buffer on sites smaller than 40,000 square feet, unless it can be shown that such development is the only effective way to maintain or improve the stability of the slope.

Development requirements on lots larger than 40,000 square feet

- 1. Wildlife Corridors.
- a. If a development site contains a natural area, which might be used as a wildlife corridor or is designated as a greenway by a City or County plan, and there are such areas adjacent, then a development proposal shall incorporate the wildlife corridor and greenway into the site design.
- b. The wildlife corridor incorporated into the site should connect the largest undeveloped or most vegetative tracts of land within and adjacent to the site in order to provide continuity of existing wildlife and plant habitats with off-site habitats.
- c. The developer shall grant a conservation easement to the City or establish a landscape maintenance agreement to ensure that the wildlife corridor is maintained.
- 2. Forests and Developed Woodlands.
- a. Forests and developed woodlands are to be maintained in accordance with Section 17.09.080 and within planting guidelines as determined by the Department.
- b. Tree replacement and fees in lieu of tree replacement shall be allowed in accordance with the provisions of Section 17.09.070.

- c. All forests designated on development plans shall be maintained to the maximum extent practicable, through conservation easements, restrictive covenants, or other protective instruments.
- d. The afforested area shall be maintained as forest cover through easements, restrictive covenants, or other protective instruments.
- e. An applicant may not clear more than thirty percent of a forest or developed woodlands on a lot or parcel, unless the Board of Appeals grants a variance and the applicant replaces forest or developed woodlands at a rate of three times the areal extent of the forest or developed woodlands cleared.
- f. The developer shall protect any habitat protection areas located in forests, developed woodlands, or undeveloped open space.
- 3. Streams and their buffers.
- a. If the project involves development activities which would cross or affect streams (perennial and intermittent streams on all sites, including ephemeral on sites 40,000 square feet or greater), the developer shall identify any such stream and their buffers (100 feet for perennial and intermittent streams, twenty-five feet for ephemeral streams) in the project area, including those off-site, which might be affected by the project.
- b. The developer shall show, as part of the site plan review requirements, that the development will:
- (1) Not cause increases in the frequency and severity of floods;
- (2). Retain existing tree canopy within the stream buffers;
- (3). Provide for the retention of the natural substrate for streambeds; and
- (4). Minimize adverse impacts to water quality and stormwater run-off.
- 4. Soils with Development Constraints. Development is discouraged on soils with development constraints. Development may be allowed by the Department of Public Works if adequate mitigation measures are implemented to address the identified constraints and if the development will not adversely affect water quality or plant, fish, or wildlife habitat.
- 5. Stormwater Management. Stormwater management technologies shall be required to minimize adverse water quality impacts caused by stormwater run-off in accordance with Chapter 17.10."

#### Amendment #17

On page 12 strike lines 27 through 30 and insert ""D. Steep Slopes and their buffers. Development is not permitted on slopes greater than or equal to fifteen percent, including a twenty-five foot buffer on sites larger than or equal to 40,000 square feet and a five-foot buffer on sites smaller than 40,000 square feet, unless it can be shown that such development is the only effective way to maintain or improve the stability of the slope."

On land 40,000 square feet or greater, the buffer shall be expanded to at least twenty-five feet at the top of twenty-five percent slopes, twenty-five feet on fifteen percent slopes that also have highly erodible soils within or immediately downslope, and five feet on fifteen percent slopes without highly erodible soils; ii. On land less than 40,000 square feet the buffer shall be expanded to at least five feet at the top of slopes."

for off-premises consumption, EXCEPT IN THE WMC DISTRICT WHERE SERVICE

AND SALE OF ALCOHOLIC BEVERAGES IS NOT ALLOWED.

 $\ensuremath{\text{\textbf{C}}}.$  The service of food items for immediate consumption, off the premises, may occur

accessory to the principal use.

D. In the WMI district, this use is only permitted as an accessory use on lots without access

to the bulkhead and is limited to one thousand square feet gross floor area. E. In the WME district AND WMC DISTRICTS, this use is only permitted as an accessory use on lots greater than ten thousand square feet in area, and is limited to one thousand

square feet gross floor area." . Seconded. CARRIED on voice vote.
