28 **WHEREAS,** pursuant to Section 4.08.030 of the Annapolis City Code, the City Council
29 may contract with the Anne Arundel County Board of Elections to administer any
30 City election.

32 **WHEREAS,** the City of Annapolis wishes to contract with the Anne Arundel County
33 Board of Elections to administer the City of Annapolis Primary and General
34 Elections that will take place on September 21, 2021 and November 2, 2021,
35 respectively.

37 **NOW, THEREFORE,**

39 **BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the City of
40 Annapolis is authorized to contract with the Anne Arundel County Board of Elections to
41 administer the City of Annapolis Primary and General Elections that will take place on
42 September 21, 2021 and November 2, 2021, respectively and to provide for the option of
43 voting by mail as may be mutually agreed to by City of Annapolis Board of Supervisors of
44 Elections and the Anne Arundel County Board of Elections.

2 this resolution shall take effect from the date of execution of the Memorandum of
