This section shall not 41 42 apply to the sound of the engine of a vessel when the engine is started, idling or running; however, 43 it shall apply to the repetitive revving sounds from the engine. 44

1	THE NOISE LEVEL STANDARDS ESTABLISHED BY THE STATE OF MARYLAND IN THE MARYLAND
2	ANNOTATED CODE, AS MAY BE AMENDED, AND ANY RELATED REGULATIONS, SHALL APPLY IN AND
3	ON ALL CITY WATERS.

5	Section - 15.06.040 - Swimming and water skiing prohibited.
6	
7	A person may not water ski in the water within Market Slip and within one hundred fifty feet of
8	any portion of Susan Campbell Park. A person may not swim in the water within Market Slip and
9	within one hundred fifty feet of any portion of Susan Campbell Park without the prior approval of
10	the Harbormaster.
11	
12	A. A PERSON MAY NOT SWIM IN THE WATER WITHIN MARKET SLIP AND WITHIN 150 FEET OF ANY
13	PORTION OF SUSAN CAMPBELL PARK WITHOUT THE PRIOR APPROVAL OF THE HARBORMASTER.
14	
15	B. The water skiing restrictions established by the State of Maryland in the
16	MARYLAND ANNOTATED CODE, AS MAY BE AMENDED, AND ANY RELATED REGULATIONS,
17	SHALL APPLY IN AND ON ALL CITY WATERS.
