And insert "IF THEY OTHERWISE MEET THE REQUIREMENTS OF THIS DISTRICT, INCLUDING THE SETBACK AND HEIGHT LIMITATIONS IN ACCORDANCE WITH SINGLE-FAMILY DETACHED DWELLINGS EXCEPT THAT FOR THE REAR YARD THE SHARED LOT LINE BETWEEN ATTACHED UNITS WILL HAVE NO SETBACK REQUIREMENT, AND SUBJECT TO MINOR SITE DESIGN PLAN APPROVAL AND REVIEW BY THE HISTORIC PRESERVATION COMMISSION UNDER SECTION 21.56 OF THIS CODE.

The Mayor shall solicit nominations VOLUNTEERS for members with no political party or are registered independents OF OTHER POLITICAL PARTIES OR NOT REGISTERED (UNAFFILIATED) WITH A POLITICAL PARTY, and from said nominations VOLUNTEERS shall select one THREE memberS.

On Page 2 lines 34-41 modify the resolve clause as follows: NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL that THE BOARD OF SUPERVISORS OF ELECTIONS HAS BEEN EMPOWERED TO CREATE an ad hoc committee FOR THE PURPOSE OF ANALYZING THE 2013 MUNICIPAL ELECTION is established, consisting of 11 members as follows: ☐ The Annapolis Democratic Central Committee shall name one co-chair and 4 additional members. ☐ The Annapolis Republican Central Committee shall name one co-chair and 4 additional members. ☐ The Mayor shall solicit nominations for members with no political party On Page 2 lines 34-41 modify the further resolve clause as follows: AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL that the BOARD OF SUPERVISORS OF ELECTIONS SHALL REPORT BACK TO THE RULES AND CITY GOVERNMENT COMMITTEE WITHIN ONE YEAR WHO WILL THEN
