#### **B.** Comments by the General Public

William Rowel, 2134 Mulberry Hill Road, Annapolis, Maryland 21409 representing the Caucus of African American Leaders thanked the Council and City Manager Andrews on behalf of the community, spoke on The Town Hall Meeting and Working Session with the Council regarding the Policy Refurbishing, the three recommendations from the committees, a request for legislation, requested that the Council respond within 30 days from today regarding the recommendation, the perceived bias in the community and legislative items.

Robert Beans, Sr., 105 Green Valley Road, Arnold, Maryland 21012 Retired Annapolis City Police Officer spoke on the December 15, 2015 meeting with the Council, General Orders, Disciplinary Procedures, Rules and Regulations and the Code of Conduct of the Annapolis Police Department, he also requested a response from the Council within 30 days.

John Talman, 1202 Marda Lane, Annapolis, Maryland 21403 spoke on Food Trucks. Jessica Pachler, 506 President Street, Annapolis, Maryland 21403 spoke on living in her house since 1999, requested a change from HACA to provide safety for their properties, shooting, drug dealers, increasing public safety, property values, gunfire and barricades, the Special Weapons Attack Team "SWAT" and multiple police issues on the HACA Properties.

Leah Weiss, 212 South Cherry Grove Avenue, Annapolis, Maryland 21401 spoke on the Historic Preservation Commission's Proposed Legislation O-07-16, concerns with the proposed legislation, on her back ground in regulatory analysis and recommended that the city hold work shops with community associations.

Brian Cahalan, 49 West Street, Annapolis, Maryland 21401 thanked the Council for their service to the community, and spoke on Food Truck legislation and requested that the restaurant owners be included in conversations, the Historic Preservation's Public Hearing on the proposed legislation O-07-16, the Ward One Meeting and the Meeting the Capital called the Closed Door Meeting.

Juliet Thompson, 9 College Avenue, Annapolis, Maryland 21401 spoke on O-7-16, her concerns regaring due process and the Historic Preservation Committee's growing administrative rights and lack of public Input, homeowners and time needed to understand the legislation.

Bevin Buchheister, 5 Wagner Street, Annapolis, Maryland 21401 spoke on the postponement of and the introduction of O-07-16, expansion of the authority of the HPC, implications of the legislation, demolition by neglect, stakeholder input and general concerns mentioned by the community.

Omar Said, 23 Francis Street, Annapolis, Maryland 21401 The Town Crier thanked the City Council, Mayor and the City Attorney and spoke on O-07-16 and requested a postponement of the legislation, the Arts in Public Places Committee and Judge Bernard Shaw.

Kurt Reigel, 307 Monterey Avenue, Annapolis, Maryland 21401 spoke on O-09-16, the removal authority and Ethic Statements, Advisory Boards and Commissions and Regulatory Boards and Commissions, the removal of section 2.08.060, citizens, appeal processes, reappointment and appointment, checks and balances being built into the legislation.
