B. Update from the Mayor

I just wanted to update you on my meeting with the HACA leadership.

- *They were very glad to hear that a total of 15 cameras are in place and that our City Council has approved the transfer of \$125,000 to support HACA and show a strong presence in the neighborhoods through additional policing and security cameras on designated streets and in parking lots.*
- *Much has been accomplished since Mr. Brown has come on board, and HACA would like to present their Crime Plan to the Council at the first City Council meeting in July.*
- *In other HACA related news... I informed them that I have been working with Comcast... and the company will be implementing low cost internet service throughout areas of Annapolis to help bridge the digital divide.*
- *I am also in talks with Northrop Grumman, asking them to donate a new computer lab to HACA locations as they have done in the past.*

- *ALSO - For the first time, Annapolis residents can purchase annual parking permits online at www.AnnapolisParking.com, effective immediately.*
 - *Now there is no longer a need to stand in line – just go online.*
 - *Residents can also get their permits in-person at the Noah Hillman Garage, located at 150 Gorman Street, in Annapolis. Informational postcards were mailed to all residents with existing permits earlier this month notifying them of their expanded options.*
 - *Residents with questions are encouraged to call SP + at 410.263.4218 for additional information.*
